## TECHNICAL IMPACT

---

### Database

The F89PRD Production Transaction database will be shut down for the normal maintenance window at 11:00 pm on Friday, March 8, 2013 and will remain unavailable until 7:00 am on Sunday, March 10, 2013. The F89PRD Production Transaction database will be ready for access at 7:00 am on Sunday, March 10, 2013.

- **NOTE:** The system cache may be cleared as part of the release process. ITS recommends that all users clear their temporary internet files when logging back into the system. Please be aware that the initial loading of pages may be slower than normal on the first business day after a release because of this. It is highly recommended that all users clear their browser cache often, especially after an update is applied to the Production Transaction database.

The CES Data Dump file contains data rows with Benefit Plan – Z001 (Smoker Surcharge). When the Create CES Accounting Entries – Load and Validation Accounting process (BOR\_CESACCT) is run an error results for each data row containing the Z001 Benefit Plan. Users are required to make correction/updates to change the Benefit Plan to a valid medical plan before completing the monthly reconciliation processes.

The CES Table Load process has been modified in order to alleviate the requirement of manual updates prior to completing the CES and RET accounting processes each month. The process will now update data rows having a BOR\_PLAN\_TYPE = Z001 and EMPLOYEE\_CONTR\_BOR <>0, with the EMPLID's medical BOR\_PLAN\_TYPE and BOR\_PLAN\_ID. This modification will save in excess of 850 manual updates across the system on a monthly basis.

Note: There could be isolated instances where a manual update would still be required but should only occur in the event of prior period charges being included in the data dump file.

A new ePro role, BOR\_EP\_REQUESTER\_YE\_CUTOFF, was released to replace the role BOR\_EP\_REQUESTER for those requesters that need access to ePro cutoff at year end.

If you are using the BOR\_EP\_MAINT\_REQ\_YE\_CUTOFF or BOR\_EP\_MAINT\_REQ\_SCI\_YE\_CUTOFF role, then those users will need to have their BOR\_EP\_REQUESTER role changed as well.

Several new security roles were added as part of this release that are applicable only to the campuses that are consolidating. The following are campus specific roles that have been added, one for each new SETID:

- BOR\_EP\_ADMINxx
- BOR\_EP\_BUYER\_CENTERxx
- BOR\_QRY\_xx000

**Configuration Changes  
for Consolidating  
Institutions**

This release includes technical changes along with the introduction of foundation data necessary for the consolidating institutions. Beginning with this release, the new institutions will begin maintaining their ChartFields and valid chartstring combinations in F89PRD. This is necessary for both Budget Prep and Banner Detail Code activities which must begin in production now.

The consolidating institutions will utilize the same ChartField values for Account. These Accounts have a SETID of SHARE. As a result of this change, programs and queries were analyzed for impact. Multiple queries and a couple of programs were modified to ensure that the new institutions use SHARE for Account. The modified programs are: Supplemental PDR – Load and Validate and Load Error Corrections (BOR\_SUPACCT).

When the new institutions attempt to maintain departments or projects, the lookup for managers will not return any employees from which to select because employees have not yet been converted to the new institutions.

As a workaround, a temporary generic manager is included in this release (Manager,Placeholder). During the FY cutover, consolidation institutions will be reminded to review all assignments to the Placeholder Manager and perform updates accordingly.
