Database	This release will be applied to the F89PRD Production Transaction database during the normal maintenance window from 11:00 pm on Friday, August 27, 2010 until 7:00 am on Saturday, August 28, 2010. The F89PRD Production Transaction database should be ready for access at 7:00 am on August 28. However, there is the possibility that it may not be available until 8:00 am. A post-release announcement will be sent as soon as the release has been completed and the system is available for your use.
	• NOTE: The system cache may be cleared as part of the release process. ITS recommends that all users clear their temporary internet files when logging back into the system. Please be aware that the initial loading of pages may be slower than normal on the first business day after a release because of this. It is highly recommended that all users clear their browser cache often, especially after an update is applied to the Production Transaction database.
