Absence Management Enhancements

The following enhancements have been configured for Absence Management:

- Enhanced FMLA Holiday processing new rules for when a Holiday falls during the employees FLMA
- Voting Leave Forecasting now employees can only select 2 hours for voting leave
- 90-Day Look Back Period for entering absences - employee can no longer enter absences 90 days or more retro to the end date of the latest CLOSED Absence Calendar

Enhanced Leave Processing to allow employees on unpaid LOA status to still process in Absence Management. Entitlements will not process, and no earnings will be generated.

Active transactions will be included in the Load Paysheet Transactions process. A paysheet will be created for the inactive employee with valid earning and deduction adjustments.

Summer Pay Component Modification

The Summer Pay modifications include:

- Checkbox on the Summer Pay page that overrides the requirement to have a combo code before the page will save. Checking this box will allow summer earnings to follow job data. Use of the functionality will be controlled on the Company Setup Page.
- Separate Check functionality for May configurable at the company level on the Company Setup page.
- New message will return when the Summer Pay page is saved. OK will need to be clicked to save the page.
- Modification was made to when the Period Closed message will be returned.

 Running total field will capture amounts entered monthly so the user can refer to the amount when entering the Summer Pay (Amt Per Summer).
 Access to Summer Pay Page when employee is no longer in an eligible pay group. Summer Pay Load process will remove the additional pay for these employees.
 Summer Pay Load-Monthly report will return two reports: Load and Error to return the employees who transfer to ineligible pay groups for summer pay processing and had Additional Pay removed.

Exempt from FUT Default	PeopleSoft delivered functionality allows for the Exempt from FUT checkbox on the Federal Tax Data page to default to checked with configuration on the Company page. With release 6.20 all OneUSG Connect companies will have this default box checked and newly hired employees will have the Federal Tax Data page default to Exempt from FUTA.
