	<b>Solution:</b> EDR Search page code was updated to reference the EDR transaction "after" table

	Prior year SCCP contributions should now be populating correctly under Bor Customization> SCCP Contributions> View SCCP.
	The SCCP County Code field that is required to be populated by the State of Georgia Charitable Campaign should now be saving for users submitting through the Make SCCP Contribution tile. This is can be confirmed by the Institution SCCP Administrators through the navigation BOR Customization> SCCP Contribution> Manage SCCP Contribution.
	For users that have made contributions in prior year, when they log into the database (ESS> Make SCCP Contribution tile) to make contributions for current year, on the Make Charitable Contributions Pledge page, the system is no longer listing prior year charities contributed to in duplicates.
	When an employee makes SCCP contributions through the Make SCCP tile, or when an SCCP Admin makes updates to the employees' enrollments or makes enrollments on behalf of the employee, the employee should get an email notification to that effect.
	On the View Contributions page (Bor Customization> SCCP Contributions> View SCCP) where the employee reviews all their total contributions for current year, we have created a field that contains a total of all contributions across all charities selected for current year.

# Payroll (PY)

ERS Rehired Retiree Employer Expense Processing	Prior to the release, a temporary method to record the ERS rehired retiree costs utilized an HCM accounting adjustment. This method is to be used for January 2021 through June 2021.
	Effective with this release, payroll deduction codes have been configured for each of the ERS plans:  ERS Old Plan – 00RERO deduction code

ERS New Plan – 00RERS deduction code GSEPS Plan – 00RGER deduction code

ERS rehired retirees should have the general deduction for their ERS plan added effective 7/1/2021. The general deductions are configured as a Non-taxable Benefit (employer cost) for the tax class.

General Deduction Codes have also been added so the correct Deduction Calculation Routine (Percent of Total Gross) and Deduction Rate or % calculates on the employee paycheck.

00RERO – Deduction Rate or %: 25.910 00RERS – Deduction Rate or %: 25.910 00RGER – Deduction Rate or %: 22.820

NOTE: If any employee is a rehired retiree in the ERS Old plan, an automated adjustment equal to a \$7.00 total refund must be added each month for the "Pickup" portion.

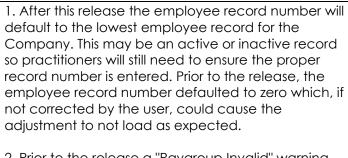

- 2. Prior to the release a "Paygroup Invalid" warning message was received if the employee's zero record was with a previous institution. Fixing the employee record to default to the lowest employee record for the Company instead of record zero also resolved this issue.
- 3. Prior to the release, employees with more than one type of adjustment (both an earnings adjustment and a deduction adjustment) were returning on separate rows, which made it appear as if the transactions were duplicated. After the release, the "Paysheet Transaction Type" will be displayed as "Deduction" or "Earnings" to differential the transactions.
