**Table Changes- Please review these important notes.**

Oracle Critical Patch Updates for PeopleSoft in release 6.54 include a change to PS\_NAMES and associated reporting tables and views such as PS\_PERSON\_NAME and PS\_PERSONAL\_DATA. This change adds 13 fields related to PeopleSoft preferred name functionality the University System of Georgia (USG) is not using. The new fields are not visible in the OneUSG Connect application.

PeopleSoft Query Managers may notice the new fields when creating or maintaining a query using the impacted records. Institution resources responsible for local integrations and reporting may notice the new fields (table columns) in the database. **USG is not changing any business process or OneUSG Connect functionality for Names and as such, strongly discourages use of the new fields for integration and reporting purposes though some may be populated via PeopleSoft code.**

The OneUSG Connect team is paying close attention to integration and reports involving names. This includes Integration Broker messaging to GeorgiaFIRST and Augusta Financials. All institutions are strongly encouraged to analyze the impact of this change and test accordingly.

<b>Release Quick Calculation Lock (SSC Payroll Only)</b>	<b>Menu &gt; Payroll for North America &gt; Payroll Processing USA &gt; Release Quick Calculation Lock</b>  When a pay calculation or quick calculation is launched, the system adds an entry to the locking table. This entry exists throughout the calculation process in the locking table as a way to prevent another quick calculation for the same parameters from launching and will be removed automatically when the associated calculation process is completed. SSC Payroll can use the Release Quick Calculation Lock page to delete unsuccessful payroll processes from the lock table.
<b>Paycheck Summary</b>	<b>Menu &gt; Payroll for North America &gt; Payroll Processing USA &gt; Update Paysheets &gt; By Payline &gt; Paycheck Summary</b>  A new view and link to paycheck details is available on the payline page as part of the Quick Calculation process. This section displays the summary and details of the calculated paychecks. It appears after the quick calculation is completed. Paycheck information is no longer available in this section if the payline that was used to calculate the paycheck has been modified.
