TL Lockdown	NAV > Time and Labor > Report Time > TL Lockdown Oracle introduced a new HR Lockdown process called Component Lockdown. Unfortunately, they updated the existing TL Lockdown process to be bypassed if the HR Component Lockdown feature has been configured. The OneUSG business process requires that both be used independently. Therefore, we have updated the Oracle process to ignore the TL Lockdown Bypass logic so both TL Lockdown and the HR Component Lockdown may be used together.
