Request Absence > End Date	The Absence Request End Date has been enhanced to default to the Begin Date entered by the Requestor for all Absence Requests. If the Begin Date is updated by the Requestor, the End date will update to match the new Begin Date. The defaulted value can be updated by the Requestor if needed. This is consistent with the pre 6.50 Absence Request business process.

MSS > Team Time Tile > Manage Absence Menu (Label Change)	<p>Within the Team Time tile, the Manage Absence menu link label has been updated to display as "Request Absence".</p> <p>The enhancement is scheduled to be available for use on Wednesday, April 3, 2024.</p>
Remove Reporting Location Menu	The "Reporting Locations" under the Team Time Tile menu has been removed from display.
TL Lockdown	<p>NAV > Time and Labor > Report Time > TL Lockdown</p> <p>Oracle introduced a new HR Lockdown process called Component Lockdown. Unfortunately, they updated the existing TL Lockdown process to be bypassed if the HR Component Lockdown feature has been configured.</p> <p>The OneUSG business process requires that both be used independently. Therefore, we have updated the Oracle process to ignore the TL Lockdown Bypass logic so both TL Lockdown and the HR Component Lockdown may be used together.</p>
