

# Benefits

ABBR process cross-reference entries to be updated	Issue: Some employee ABBR's are being calculated incorrectly. Root cause: The cross-reference table entries that the ABBR process uses did not accurately reflect changes that had been made to the current pay matrix. These cross-reference entries govern how the ABBR process performs its calculation. Solution: ITS will update the cross-reference entries for the ABBR process to match the current pay matrix.
TIAA Daily Census process – Augusta only	Issue: Augusta to stop using the benefit program RES. Root cause: The census process uses the presence of this Benefit program to prevent opening a retirement election window for their resident employees. Without a change, in error election windows will open. Solution: Update the daily census process to suppress election windows for Augusta residents based on their job code instead of the current benefit program.





# **Commitment Accounting**

Express Direct Retro (EDR) - Deleting added Adhoc approvers:	Navigation: Menu > Manager Self Service > Express Direct Retro (EDR) > Retro Distribution Request. Issue: If the additional approver was added to a submitted EDR, the user was not able to delete the added approver. Root Cause: The delete Adhoc code was not
	present. Solution: Correct code was added to the process.
Accounting Adjustments (AA)	Navigation: Menu > BOR Customizations > BOR General Ledger > Accounting Adjustment Upload
	Issue: If a future job code change has been made, AA Upload process will run to No Success, even if job code change is another Active row.
	Root Cause: View assessing JOBCODES is using System Date {SYSDATE} as part of the upload assessment process.
	Solution: New assessment view for job code based on Accounting Date rather than System Date.





# Payroll

Payroll for North America > Payroll Customization > Additional Pay Load	<b>Issue 1</b> : When an employee has multiple rows for an earnings code on the additional pay spreadsheet, the additional pay load only accepts the first row.
	<b>Resolution 1:</b> All rows for the earnings code will load if the additional sequence number is unique for each row.
	<b>Issue 2:</b> Inaccurate message "Combination Code is invalid" is returned as an error for some employees.



	<b>Resolution 2:</b> The validation logic will be enhanced
	so message is not returned.
Summer Pay Page Payroll for North America > Payroll Customization > AYP/Summer Pay > Use > Summer Pay	Issue: The Summer Pay Load process writes data from the Summer Pay page to Additional Pay page with the "Prorate Additional Pay" box checked. Typically, the Summer Pay Amount should be paid in full and not pro-rated. Resolution: The Summer Pay Load process will no longer include a check in the "Prorate Additional Pay" box when it writes to Additional Pay. Any required proration will be manual.
Summer Pay Page Payroll for North America > Payroll Customization > AYP/Summer Pay > Use > Summer Pay	<b>Issue:</b> The Summer Pay page pulls data from job data as of 05/31/YYYY to populate the top half (non-editable) portion of the Summer Pay page. One of the fields is position number. An issue arose where the employee is in Position Number A and has summer pay added. The employee then has a retroactive job data update to Position Number B. The summer pay amounts entered for Position Number A, while not visible on the page, are still being captured by the Summer Pay Load process and loaded to Additional Pay along with the summer pay amounts for Position Number B. <b>Resolution:</b> The Summer Pay page will be available for editing for both positions. This will allow the prior position's Summer Pay to be removed if required.

# Recruiting

Delete Draft Job Openings Recruiting Self Service > Search Job Openings > Status: Draft	Currently, practitioners are unable to delete draft job openings-the system spins and will eventually time out/log the user out. Practitioners have been submitting tickets with the job openings they would like deleted and those have been removed via DBI process. After the release, practitioners will be able to successfully delete draft job openings, both individually and in bulk.
Job Open Notify Role BOR_JOB_OPEN_NOTIFY	Notify Role for approved job openings currently exists but is not active/working. After the release,



users with this role should receive notifications
when a job opening has been approved.

Manager Self Service- ADD/CHANGE POSITION	Users should no longer receive an error when attempting to view Approved Add/Change position transaction on the Manage Positions tile. MSS Home Screen>Manage Positions
Manager Self Service-CHANGE TIME APPROVER	Users should no longer get timed out of OneUSG Connect when attempting to search for new Time/Absence approver name in the Request Change Time/Absence approver transaction.

Reported Time Audit	Navigation: Menu > Time and Labor > View Time > Reported Time Audit. Issue: When reviewing information on the Reported Time Audit page, the initial audit data is displayed. However, when the chooses "History" to review the details of the audit, the page times out. Solution: Modifications were made to increase performance and prevent the page from timing out.
Batch Approved Reported Time Audit	Navigation: Menu > Time and Labor > Approve Time > Batch Approve Reported Time. Issue: Request to add audit when Reported Time is Batch Approved Solution: Add Operator ID (OperID) to batch approve reported time process. Audit will show who approved time when batch approval process is run.
