- **Final PRIMO NERS Enhancement Requests for 2020 (USG enhancement in red):**
  - 6718 Add Journal Coverage Dates to Brief Results Page (Votes: 6550 Dev. Points: 70)
  - **6440 Create spinner or indicator for GetIt frame to indicate content is loading (Votes: 5347 Dev. Points: 5)**
  - 6702 Ability to dedup or FRBR between local data and CDI data (Votes: 5217 Dev. Points: 50)
    - The solution will allow more control for customers by not grouping the results, but rather allowing more control on the activation side such as to not include a Book package from CDI, which will mean no duplicates with the local Books, but to choose to still include all the Book Chapters of that package
  - 4457 Fix indexing of words with hyphens (e.g. hand-book, etc.) (Votes: 4017 Dev. Points: 25)
    - The solution will be for a closed list, not any hyphenated term
  - 6637 Extend customization options for all request forms (Primo VE) (Votes: 2309 Dev. Points: 40)
  - 6710 Add support for microlanguages ISO 639-3 and language codes recognized by Library of Congress (Votes: 1067 Dev Points: 60)
  - 6552 Add 505\$t to Primo VE TOC and Title indexes (Votes: 1173 Dev. Points: 10)
- **Final ALMA NERS Enhancement Requests for 2020:**
  - Provide the ability to identify broken links to electronic and digital resources
    - Incorporate automatic link checking functionality into Alma that provides customers with regular reports of broken links for electronic and digital resources.
  - Improve Repository Search functionality with free text options for MARC tags and subfields in Advanced Search
  - Resource sharing: updates to due dates of borrowing request loans to be reflected in resource sharing and fulfillment
  - If updating the due date of a borrowing request on loan, it should be reflected in both the patron account and the borrowing request, irrespective of where it was updated. Using the renew option in the borrowing request will update the due date in both borrowing and the patron side, but it should also be possible to update the due date in the patron side and for this to be reflected in the borrowing request, rather than having to do this twice.

### **ICOLC OCLC TASK FORCE UPDATE:**

Lucy Harrison provided the following ICOLC OCLC Task Force update:

- Issues brought up to ICOLC
- Meeting with OCLC Representatives at ALA Midwinter
- Questions sent to OCLC
  - Pricing too high/pricing models not transparent
  - How to ensure WorldCat remains (returns to?) an accurate and accessible reflection of the world's library holdings
  - Need for sustainable and flexible product development that addresses relevant standards and interoperability
  - General concerns about plans for future given external threats
- Presentation at ICOLC meeting 7/22/2020
- Written "takeaway" received from OCLC some months after the presentation
- ICOLC task force identifying specific actions requested



**ILS DISCUSSION – PLANNING AND PATH FORWARD:**

Lucy Harrison led the following discussion by the group of the ILS – Planning and Path Forward:

- Current Situation: GIL manages Alma Integrated Library Platform for USG. TCSG also on Alma/Primo, but not managed by GIL
- Problem: It’s expensive. Negotiation reduced annual subscription costs some, but:
  - Predecessor system (locally-hosted, Voyager) was much less, even including hosting costs
  - Several peer consortia pay less than we do
  - Our state funding is declining
- Negotiated terms for the next five years, but planning an RFP for FY21-22:

2022-23	3 <sup>rd</sup> year of renewed terms	Decision on system for 2025 onwards (early in FY) Robust plan for moving to new system (if necessary – late FY)
2023-24	4 <sup>th</sup> year of renewed terms	Moving to new system (if necessary)
2024-25	Final year of renewed terms	Moving to new system (if necessary)

- Potential Alternatives
  - Commercial solution
    - Ex Libris or OCLC, realistically
    - RFP may reduce price
  - Open source solution
    - PINES (GPLS) has proven robust
    - FOLIO in development for academic institutions
    - Consortial workflows still in development
    - Vendors provide hosting and support options (3+)
    - Could also host locally
- Potential Next Steps
  - Traditional RFP?
    - Commercial vendors and OS hosting/support vendors can respond
    - Need robust requirements
    - How to consider self-hosting?
  - Evaluate Open Source Options First?
    - Still need robust requirements
    - How to get costs from OS hosting/support vendors? RFP? RFI?
    - If unsuccessful, delays vendor RFP
  - Start Working on FOLIO?
    - Can do this either way

- Needed Either Way
  - Requirements
    - Old GIL requirements (plus SC, Florida)
    - Functional committees provide expertise
    - Minimum requirements?
  - Open Source evaluation and gap analysis
  - Decision early next FY:
    - Is Open Source viable?
    - If so, how to proceed? (Funding, staff resources, preferred infrastructure, etc.)
  - Discussion at Fall and Spring RAEL meetings

### **USG RETIREES ACCESS:**

USG Retirees Council Members Kathy Tomajko, Dorothy Zinsmeister and Ron Bohlander led the following discussion concerning USG Retiree Access with the group:

- Approved policy at Fall 2019 meeting
- Some implementation concerns:
  - How to determine retirement status?
  - Emeritus status not consistent
  - COVID!
- Policy statement in place on GALILEO website
- Local implementation issues?
- Local awareness of policy?

Sonya Gaither provided an Assessment Committee update and Ken Henslee provided a review of the Annual Statistical Reports and the OpenAthens statistics tool.

### **LIBRARY STAFFING/BUDGET ISSUES:**

Laura Clark and David Evans led the following discussion of the Library Staffing/Budgetary Issues by the group. They reviewed the ACRL Standards (Performance Indicators) and provided some data to provide context for the current situation in the USG (staffing levels at USG institutions; amount spend on library resources per FTE). They also provide some national context from the 2018 Academic Library Trends and Statistics from ACRL Metrics (<https://acrl.ala.org/acrlinsider/archives/17996>)

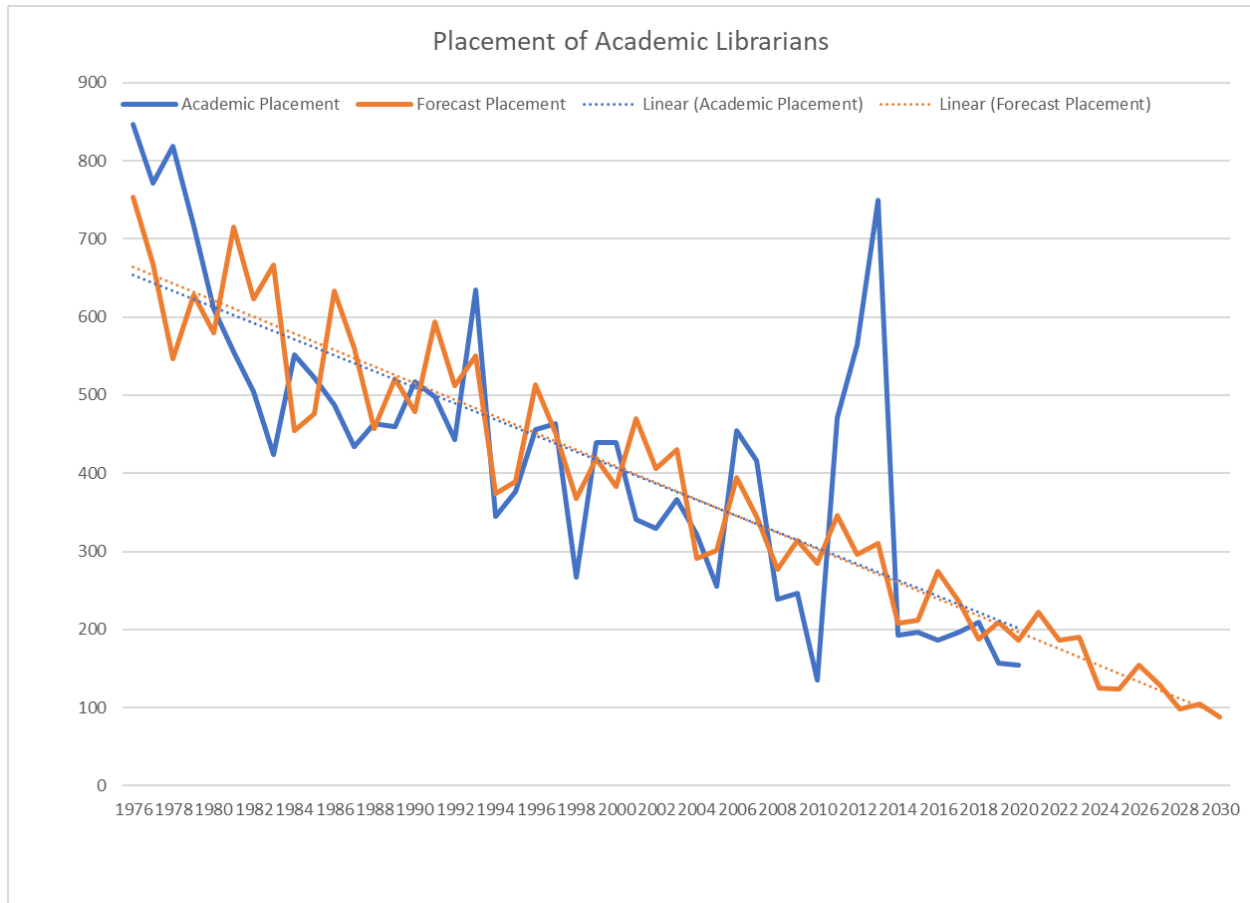
- Salaries accounted for 55.6% of the total library budget
- Spending per FTE student averaged \$400 for baccalaureate schools

- Staffing at baccalaureate schools averaged 5.44 FTE librarians

#### Issues to Consider

- How much does the USG offset the amount colleges spend on FTE students?
- How do we examine the library resource amount in relation to other colleges our size, the USG’s contribution, and our individual institution?
- How do we discuss the budget cuts due to COVID-19?
- At what point do smaller colleges review their GIL and GALILEO costs?
- Does the USG have power to recommend standards (library budget expenditures) for the different institutional rankings?
- How do we provide context to FTE librarians?
  - Full time versus part time
  - Budget expenditures for salaries

David also provided a chart he had created showing placement trends for the past 50 years:
