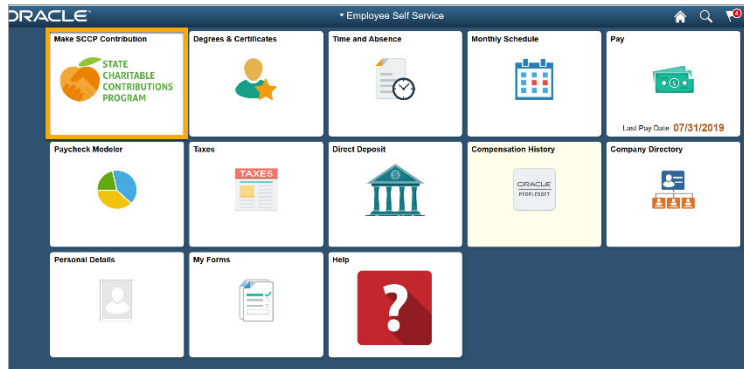
1. Make SCCP Elections.

- a. From the Homepage of Employee Self Service, click the **Make SCCP Contribution** tile.



- b. Select your **County of Residency**.

c. Once you select the appropriate county, click **Next**.

You may select up to 12 different agencies, making a minimum donation of \$1 per pay period per agency. Once you are satisfied with your changes, click **Submit Pledge**. Remember that every dollar counts.
