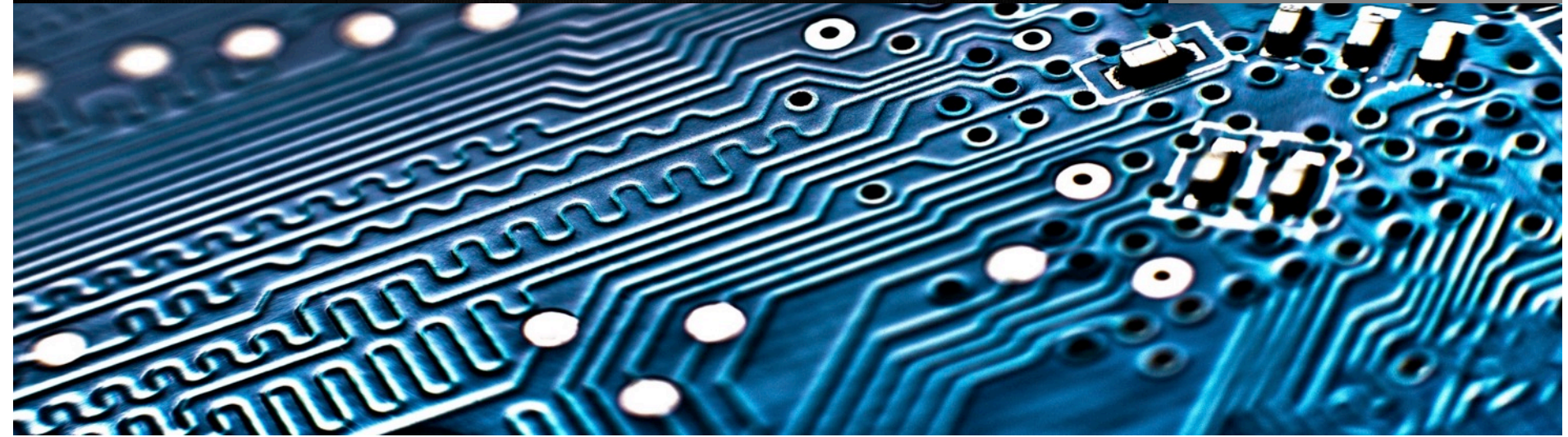

# Classification of Instructional Programs and the 2020 Update

- CIP: Federal taxonomy of instructional programs
  - 6 digit numerical code (2 digit suffix added by institutions)
  - 010303 Aquaculture: A program that prepares individuals to select, culture, propagate, harvest, and market domesticated fish, shellfish, marine plants,....
  - Updated every decade
    - Refine descriptions, identify new codes, move or delete existing codes
    - CIP 2020 [website](#)

  - Facilities: Room CIP
  - HR: Employee field of study, field of teaching
- Reporting
  - USG [website](#): Program Enrollment, Degrees Awarded, Credit Hour Attempted (funding)
  - [IPEDS](#)
- Implement changes for start of AY 2021 with Summer 2020 MT collection

# Steps for 2020 Update

- Step 1: Registrars work to identify list of program and course CIP codes to be changed
  - RPA provided each campus a list of suggested changes and instructions on how to review and confirm which changes will be made

  - Campuses will update Banner following “Updating from the 2010 to the 2020 CIP Codes” Business Practice
  - All changes to DMA and Banner must occur between Spring 2020 EOT and Summer 2020 MT
