

Tuition Recommendations

Undergraduate Tuition

- No tuition increase for undergraduate students at 25 of 26 institutions 0% increase
- \$17/hour increase for in-state students and \$64/hour increase for outof-state students at Middle Georgia State University

Graduate Tuition

- No tuition increase for gradate students 0% increase
- Reduce by \$50/hour the Master of Biomedical Innovation and Development at Georgia Tech

5th year out of last 7 years with no tuition increase for most institutions

- Board approve the **graduate** tuition rates for fiscal year 2023 (Appendix IIB)

Mandatory Student Fees

Special Institutional Fee


- Enacted during the Great Recession to address significant funding reductions
- Generates approximately \$230 million per year for USG institutions
- Rates range between \$170 to \$544 each semester
- Restoration of prior year austerity cuts allows for elimination of this fee

FY 2023 Mandatory Fees

Recommendations:

- 4 fee increases related to PPV projects at Columbus, Fort Valley, Valdosta, and Gordon.
- Increase activity fee on UNG Gainesville to same rate as UNG Dahlonega
- Kennesaw State \$25 reduction of mandatory parking fee and increase to voluntary permit fee
- Valdosta State net \$0 redirection between healthrelated fees
- Fort Valley State net \$0 redirection from technology fee to student activity fee

Mandatory Student Fees are the primary funding source for student activities, student technology, athletic programs, student centers, parking and transportation, health services, and other non-academic, student-focused facilities.





Recommended: That the Board approve the proposed mandatory student fees for fiscal year 2023 for institutions of the University System of Georgia, to become effective Fall semester 2022 as detailed in Appendix IIIA

Elective Fees and Special Charges Requiring BOR Approval

- Enhanced Board Policy to increase review and oversight of certain elective fees and special charges
- Most elective fees and special charges will continue to be set at the institution level
- No increases to Board-approved fees and five fees recommended for discontinuation


