- GeorgiaFIRST Marketplace Users will be prompted to set up their Amazon Business Account Profile on their initial access to the site. This is a one-time process that will not be required after it has been completed unless the user's email address changes.
- Please note that your email address MUST be populated on your PeopleSoft profile in order to use the Amazon punchout.

Migrate Your Existing Amazon.com Consumer Account

- If you already have an Amazon.com (Non-Business) Account tied to your work email address <u>and utilize this account solely for business purchases</u>, you can migrate this existing account to your Agency's Amazon Business Account.
- Sign in using the same password that you already use for your existing Amazon.com account.

SCENARIO 3

De-register Your Existing Amazon Business Account (w/One User Associated On Account)

- If you already have an Amazon Business Account tied to your work email address <u>and utilize this account solely for business purchases</u>, you will need to first deregister your business account by going to https://amazon.com/gp/b2b/manage/deregister
- Sign in using the email address and password that you use when accessing your Amazon Business Account.

- If you are the only individual associated with the account, proceed with the steps to deregister your account.
- After completing the steps, repeat the steps to access Amazon Business through Georgia *FIRST* Marketplace.

<u>De-register Your Existing Amazon Business Account</u> (w/Multiple Users Associated On Account)

- If you already have an Amazon Business Account tied to your work email address and the account has other email addresses associated with it, you will need to submit a request to deregister your business account by going to https://amazon.com/gp/b2b/manage/deregister
- Sign in using the main email address associated with the account and the password used when accessing your Agency's Amazon Business Account.

After completing the request, you will note the following message directing you to contact Amazon's Business Customer Support. Select the "Contact Us" Button.

From Your Browser Settings: You Must Allow Pop-ups

to view the Amazon Tab. After you select the Amazon Punch Out Icon located in Georgia *FIRST* Marketplace, the Amazon Business Marketplace will open in a new browser tab separate from the Georgia *FIRST* Marketplace.

Items selected and added to your Cart while shopping in the Amazon Marketplace will transfer to your open session in Georgia *FIRST* Marketplace.

When shopping on the Business Account, you will receive FREE 2-Day shipping on orders of \$49 or more of eligible items. These Items are either:

- Prime Items
- Items shipped and sold by Amazon.com

Payment

Payments to Amazon will be made via invoice. e-Invoices will transmit electronically via the GeorgiaFIRST Marketplace, much like many of our other current GFM suppliers.

Warranties

Georgia FIRST Marketplace Users should be aware that items purchased from the Amazon Business Marketplace are not part of a negotiated Statewide Contract and therefore are not covered by terms and conditions negotiated by the State, including, but not limited to, warranty provisions (including return provisions), delivery provisions (including FOB provisions), or liability provisions. Users are cautioned to review terms and conditions relating to each purchase and assess risk accordingly.

Returns & Exchanges

To return or exchange an item, hover over (User)'s Account for Business > Orders to view your complete order history.

- · Select Return or Replace items at right of product image
- Select reason for return
- Print label and authorization
- · Prepare package and return label
- Items shipped and sold by Amazon.com orders can be returned within 30 days or receipt of shipment.
- If shipped and sold by a 3rd party, policies can vary. If you have questions, contact the Amazon Business customer service team.

Refunding Sales Tax on Tax-Exempt Orders

While Amazon Prime Sellers participate in the Tax Exempt Program, there are some select sellers outside of the Amazon Prime Program whose items may not reflect a Tax Exempt Status during Check Out. In the instance that there is sales tax charged on an order that should have been tax exempt based on your Organization's Tax Exemption status, please take the following steps to receive a tax refund on the order:

- 1. Go to "Your Orders" on Amazon.com.
- 2. Locate the item that was charged tax and click the "Contact the Seller" button.
- 3. If the button is not there, they should call the ATEP support line at 1-888-280-9552.
- 4. Enter the subject as "Tax Exemption Refund Request."
- 5. Include the order number and the amount charged.

You will either receive a response within 72 hours or the refund will be issued to your account automatically.
