



Viewing Statewide Contracts in the Georgia*FIRST* Marketplace

This job aid is designed to provide instructions on how to view statewide contracts within the Georgia*FIRST* Marketplace (GFM) while highlighting key aspects of the contract setup.

First, navigate to the Catalogs & Contracts icon on the left menu and click on "Search Contracts".

The search will allow you to perform a simple search (enter a keyword, contract name, contract number, supplier name, etc.).

You can perform an advanced search by clicking that option in the top right corner. The advanced search page provides more filters for narrowing your search results.



The contract documents reside here. Pricing, information, and benefit sheets provide pertinent information relating to the contract. To see the documents, select the link; the documents will open in either a PDF or Word format.

Although the information contained in a contract varies depending on the contract type, all contracts will have a benefit sheet and an information sheet.

The benefit sheet provides background information about the contract, including key factors such as contract name and number, contract term, and suppliers awarded. It also includes the key benefits of the contract.







While the information sheet provides some of the same information as the benefits sheet, it also gives contact information for the supplier, in particular who to contact with contractual questions. This document also shows ordering and remitting information, as well as the terms of the contract.
