Preparation for Testing

The Facilities Inventory Release 1.2 must be applied to your TEST database used to prepare for testing. Please follow the steps below to prepare for testing the release:

Step 1

Apply the Facilities Inventory Release 1.2 to the Banner database using the parameters for Fall FT 2020.

Step 2

Setup and/or identify test cases for testing the extraction and editor.

Step 3

In Banner, run the Data Collection Extraction process (ZADMETL) from Banner Job Submission (GJAPCTL).

Step 4

Turn on the ITS version of GlobalProtect VPN. For download, install, and login instructions, email <u>DW Test@usg.edu.</u>

Step 5

Run the USG Extract in the TEST environment using the following URL:

Step 6

Review the Data Submission Error report to validate changes included in the release in the Cognos TEST environment using the following URL:

Classification of Instructional Programs (CIP) Code

Purpose

In prior Facilities Inventory Data Collections, institutions were required to submit a Classification of Instructional Programs (CIP) Code (BRM007) for certain Room Use Code (BRM004) values. To improve data quality and lessen the burden on institutions, the CIP Code will no longer be collected starting with the Fall FT 20212 Facilities Inventory Data Collection.

Functionality delivered with this release:

• Remove Classification of Instructional Programs (CIP) Codes from the Facilities Inventory Data Collection (modification)

Test Scenario 1:

In Cognos, generate a Data Element Dictionary using the Data Dictionary > Download PDF option. For data element Classification of Instructional Program Code (BRM007), verify the following:

- The Validation Rule Status for VBRM015 shows "Inactive".
- The Effective Terms section displays "End: 20212"
- The Change History Displays the following:
 - Academic Term: 20212
 - Date: September 4, 2020
 - Change Notes: Deactivated edit VBRM015

Test Scenario 2:

Run the ZADMETL process for parameter value F to generate output for FIDC. Review the .lis file output for any errors. If ZADMETL completed successfully, run the FIDC extraction. In Cognos, review the Data Submission Errors report to ensure that the following error was not received:

• VBRM015 - CIP code must not be null where room use code is 211, 221, 250, or 255.

Test Scenario 3:

In Cognos, select the link for Data Collection Review report Building and Room Summary. From the building list, select the link for a building to view the Room Summary report. Verify the CIP_CODE column is not populated.

Test Scenario 4:

In Cognos, select the link for Data Collection Review report Table Dump – FIDM Room. Verify the CIP_CODE column is not populated.
