Local Area Network File Server

Portions of this release will reside on the local area network file server. Please forward this announcement to appropriate technical support staff at your institution.

Domain Name System Registration

Several of the University System Office Applications require that institutions transfer data to and from OIIT servers using FTP. For security purposes, OIIT requires that computers making FTP connections to our central services be registered with a name in the Domain Name System (DNS), and registration in the DNS is a common practice. To have your computer registered, or to verify that it is registered, please contact your local technical support staff for your institution. An institution's network support group is often the group responsible for DNS registrations.

OIIT recommends that all computers connected to the Internet have a registration entry in the DNS.

Functional Information

This section summarizes the functional changes to the Georgia Banner Enhanced Student and Financial Aid Systems for 7.0

The Georgia Enhancements 7.0 release includes modifications to all forms and processes to incorporate the new "look and feel" of the Banner baseline V7 deliverables. In an effort to conform to baseline standards, the following issues were remediated for the Georgia Enhancement forms and processes:

- SunGard Higher Education Solutions (SHES) has a new standard of spelling out abbreviations. Most abbreviations on field names in Georgia Enhancements have been expanded.
- Block headers have been incorporated in multi-block forms.
- Fixed Length property fields have been implemented to force users to enter values for fields with the appropriate number of characters. **Note**: Oracle has discontinued the fixed-length property field.
- There is a new SHES standard to apply international number formatting to all number fields. This functionality has been incorporated in all Georgia Enhancements.
- SHES has added Code/Description prompts to customize the text color for visual identification of searchable/LOV fields to the General User Preferences Maintenance form (GUAUPRF).
- In Banner Baseline V7, SHES has changed how they process creation of generated IDs and PIDMs. Instead of using SOBSEON, an Oracle sequence is now being used.
- Titles of List of Value (LOV) boxes were added and/or corrected.
- Corrections have been made so that the LOVs work in a standardized manner for all Georgia Enhancement processes.
- Parameters in the .lis files have been reordered to match the order in Job Submission.
- As part of the 7.0 Baseline UI standard design, when a code description is display only, there will be no text box. When a field is actually 'updatable,' the text boxes will be visible.

Defect Correction for Admissions Index Calculation Form (ZORINDC)

ZORINDC Defect Correction

The Admissions Index Calculation form did not display an error message in the hint text line if an invalid value was entered in the "Run Mode" parameter (06). The LOV did not provide query access for the "Selection Identifier" parameter (02).

Functional Impact

LOV functionality will now be available for applicable parameters. Also, validation will be performed for applicable parameters

Defect Corrections and Enhancements for CPE Results Update Process (ZORCPER)

ZORCPER Defect Corrections and Enhancements

The CPE Results Update Process did not display an error message in the hint text line if an invalid value was entered in the "Run Mode" parameter (12).

The following enhancements were made to the CPE Results Update Process:

- Default run mode for process has been changed from "update" to "audit."
- USER_ID has been added to the parameter list on the generated .lis file.

Functional Impact

Validation will now be performed for applicable parameters. Also, the process will run in "audit" mode as a default and the parameters have been updated in the .lis file.

Enhancements for CPE Requirement Update Process (ZORCPED)

ZORCPED Enhancements

The following enhancements were made to the CPE Requirement Update process:

- USER_ID has been added to the parameter list on the generated .lis file.
- The following parameters were renamed for consistency:
 - Test Start Date = Start Date
 - End or Remove Hold = Update/Delete

Functional Impact

The parameters have been updated in the .lis file.
