She noted that CISI policy changed language on return ticket/trip interruption – no benefit change, just language.

Tammy suggested that under new USG leadership it could be appropriate time to suggest changes to the BPM, and she would work with SAC if a request could be formulated.

6. Lorie brought up the issue of current tensions between Ukraine and Russia and its implications for study abroad in the area. Also asked about security positions on campuses, and Anticipated Title IX changes coming in 2023.
