# **April 14, 2015**

### 1. Fiscal Year 2015 Amended Budget

<u>Recommended</u>: That the Board approve the allocation of state appropriations for the fiscal year ("FY") 2015 amended budget.

<u>Background:</u> The FY 2015 state funds original budget for the University System of Georgia was \$1.939 billion. The final, amended state funds budget for the University System of Georgia is \$1.945 billion, which is a net increase of 0.29% from the original budget for FY 2015.

The FY 2015 amended budget includes an increase in state funding of \$4,885,853 to support clinical trials on cannabidiol for children with medication-resistant epilepsy and \$647,875 to establish the Georgia Film Academy in partnership with the Technical College System of Georgia.

The FY 2015 amended budget also includes one capital item related to the University System of Georgia:

1. Transfer authorization for \$1,350,000 in 5-year taxable bonds for equipment for the Athens and Tifton Veterinary Diagnostic Laboratories (HB 744, Bond #113, page 134, line 4017) from the Department of Agriculture to the Board of Regents


All changes identified specifically by House Bill 75 were made accordingly.

House Bill 75, the Amended Appropriations Act for FY 2015, was signed by the Governor on February 19, 2015.

### 2. Fiscal Year 2016 Tuition

<u>Recommended</u>: That the Board approve the tuition rates for fiscal year 2016, to become effective Fall semester 2015. Recommended tuition rates appear in Appendix IA (Undergraduate Tuition) and Appendix IB (Graduate, Professional Programs and Distance Learning Tuition).

<u>Background:</u> Tuition and fees in the University System are an excellent value for students; among all 16 states of the Southern Regional Education Board (SREB), Georgia ranks 10<sup>th</sup> among four-year institutions and 7<sup>th</sup> among access institutions for FY 2014.



### **Proposed Undergraduate Rate Increases:**

Maintaining affordability is one of the highest priorities of the University System of Georgia and, as such, the University System of Georgia is committed to keeping tuition rates low.

The recommended strategy for FY 2016 balances affordability, access and quality across all sectors of the University System, recognizing that research institutions must remain nationally competitive.

Specifically, the components of the undergraduate rate increase proposal are as follows:

- 1. A tuition increase of 2.5% for all institutions across all sectors, except as noted below.
- 2. A tuition increase of 9% for the Georgia Institute of Technology and the University of Georgia.
- 3. A tuition increase of 5.5% for Georgia State University and Georgia Regents University.

### 2. Fiscal Year 2016 Tuition (Continued)

4. A tuition increase of 4.4% for Kennesaw State University.

- 5. A tuition increase of 9% for Middle Georgia State University.
- 6. A tuition increase of 3% for Georgia College and State University. This increase will enable the institution to attract and retain faculty critical to its liberal arts mission.
- 7. A tuition increase of 5% for the University of North Georgia. This increase will enable the institution to address critical staffing and faculty needs.
- 8. A tuition increase of 8.3% for Georgia Gwinnett College. This increase represents phase one of a two-year plan to bring the tuition closer to the tuition of state universities, recognizing that Georgia Gwinnett College's mission is more closely aligned with the state university sector.
- 9. A tuition increase of 9% for Atlanta Metropolitan State College. This increase represents phase one of a two-year plan to bring the tuition in line with other institutions in the balanced bachelor's and associate state college sector.
- 10. Further, out-of-state tuition will increase by the same percentage for all institutions, except Georgia Institute of Technology, Georgia Regents University, Georgia State University, the University of Georgia and Georgia College and State University. Out-of-state tuition will increase by the same dollar amount as in-state tuition for these five universities, except Georgia Institute of Technology, which will increase by 6%.

# 2. <u>Fiscal Year 2016 Tuition (Continued)</u>

The recommended tuition differentials for the research institutions are market driven and based on comparative tuition data for peer institutions.

A 9% in-state tuition increase is recommended for the Georgia Institute of Technology. The Georgia Institute of Technology is world-renowned and competes on a global scale. It offers many high-cost programs and must generate sufficient revenues to remain technologically competitive, retain superior faculty, keep class sizes small for maximum student-faculty interaction and provide quality program offerings. Based on tuition data of peer institutions, the undergraduate tuition rates at the Georgia Institute of Technology are below the average tuition rates of their peers. A 9% tuition increase continues to move the Georgia Institute of Technology to their peer tuition average.

In-state tuition increases of 9%, 5.5% and 5.5% are recommended for the University of Georgia, Georgia Regents University and Georgia State University, respectively. The recommended tuition increases will allow these institutions to recruit and retain the highest quality faculty. Maintaining quality in the classroom and a competitive edge are essential for all research institutions.

In FY 2014, a tuition structure was implemented at Georgia Regents University to create a new, non-health sciences tuition rate that increases progressively to match the Georgia State University rate over a seven-year period. The FY 2016 in-state and out-of-state undergraduate tuition rates for Georgia Regents University Summerville Campus reflect year three of the seven-year plan. These rates apply to all new students at the Georgia Regents University Summerville Campus.

### **Tuition Structure for the Newly Consolidated Kennesaw State University:**

On January 6, 2015, the Board approved the consolidation of Kennesaw State University and Southern Polytechnic State University. The new undergraduate tuition rate reflects an increase of 1.8% needed to blend the existing tuition rates of Southern Polytechnic State University and Kennesaw State University and remain revenue neutral. All rate structures are subject to the normal increases approved by the Board.

# **Tuition Structure for Middle Georgia State University:**

On March 18, 2015, the Board approved Middle Georgia State College to revise its institutional mission statement to reflect that of an institution in the state university sector and to change its name to Middle Georgia State University.

# 2. <u>Fiscal Year 2016 Tuition (Continued)</u>

The new undergraduate tuition structure at Middle Georgia State University is designed to balance student interests and provide the resources necessary to transition the college to university status. The tuition rate will be raised progressively to match the university sector rate over a six-year period. All rate structures are subject to the normal increases approved by the Board.

### **Graduate and Professional Program Tuition:**

The Board of Regents' policy on graduate tuition allows institutions having graduate programs to request a separate, "core" graduate tuition rate based on market and cost considerations. Similarly, institutions can request approval for separate tuition rate adjustments for select, competitive professional programs. The recommended "core" graduate tuition rates appear in Appendix IB, as do the recommendations for changes in tuition rates for professional programs.

All graduate students enrolled at Southern Polytechnic State University during the 2014-2015 academic year will continue to be assessed the graduate tuition rate of the former Southern Polytechnic State University. This rate is subject to the normal increase approved by the Board.

Middle Georgia State University will begin to offer graduate programs beginning in Fall 2015. The core graduate tuition rates are included in Appendix IB. The core rates were benchmarked against the core graduate rates of other USG institutions.

### 3. Fiscal Year 2016 Mandatory and Elective Fees

<u>Recommended</u>: That the Board approve the proposed mandatory student fees for fiscal year 2016 for institutions of the University System of Georgia, to become effective Fall semester 2015. Recommended mandatory student fees appear in Appendix II.

<u>Further Recommended</u>: That the Board approve the elective fee requests for Kennesaw State University, Georgia Gwinnett College and the College of Coastal Georgia as outlined on page 8. These elective fee requests require Board approval based on Board Policy 7.3.2.2.

<u>Further Recommended</u>: That the Board approve the housing and food service fee increases that support debt service as outlined on page 9. Board Policy 7.3.2.2 requires Board approval for housing fees and food service fees that support debt service.

<u>Background</u>: By policy, the Board of Regents approves all mandatory fees and fee increases. The major mandatory fees include intercollegiate athletic fees, student health service fees, student activity fees, parking and transportation fees, technology fees, and, in recent years, fees to support private funding of facilities such as recreation centers, parking decks, student centers and similar projects. The recommendations contained in Appendix II were developed following a review of institutional fee requests that considered, among other things, the current financial position of the programs and activities supported by fees. Further, each request was accompanied by documentation provided by the related institution concerning the committee review process required by Board of Regents policy, which requires each fee and the budget it supports to be reviewed by a committee comprised of at least fifty percent students, with a minimum of four students.

A summary of fee recommendations is provided below.

# **Fee Structure for Newly Consolidated Kennesaw State University:**

On January 6, 2015, the Board approved the consolidation of Kennesaw State University and Southern Polytechnic State University. The mandatory fees for the newly formed institution are included in Appendix II. Wherever appropriate and feasible, mandatory fees for the consolidated institution do not exceed the highest fee level of the two institutions. Mandatory fee rates were set to be revenue neutral except to address underperforming public private venture (PPV) projects. Additionally, a new fee for shuttle operations was created to ensure access for all students to both the Marietta and Kennesaw campuses. The new fee structure will be effective beginning Fall 2015.

# 3. Fiscal Year 2016 Mandatory and Elective Fees (Continued)

# **Elective Fees Requiring Board Approval:**

The policy revisions adopted by the Board in January 2010 require certain elective fees to be approved by the Board. They include any fee or special charge that is required to be paid by all full-time, undergraduate students at the institution or by all undergraduate students in a specific degree program, with the exception of specific course fees for supplementary costs. In February 2015, the Board approved additional policy revisions to strengthen policies regarding elective fees. Institutions that currently charge fees to students that require Board approval, but did not under the old policy, received a one-year grace period to continue to charge these fees as elective fees without Board approval. No action by the Board is required for FY 2016, except as noted below.

In accordance with the Board Policy, the following elective fees are recommended for approval.

# 4. Fiscal Year 2016 Budget Allocations

<u>Recommended</u>: That the Board approve the allocation of state appropriations for fiscal year 2016 among institutions and operating units of the University System of Georgia ("USG") as outlined Appendix IIIB and Appendix IIIC. All allocations for FY 2016 are pending the Governor's signing of House Bill 76, the Appropriations Act for FY 2016.

<u>Further Recommended</u>: That the Board approve the FY 2016 Capital Budget, totaling \$334,190,000 as outlined in Appendix IV.

<u>Background:</u> The total state funds budget for the USG at the beginning of FY 2015 was \$1.94 billion. The recommended state funds budget for FY 2016 is \$2.02 billion. Appendix IIIA lists the changes from FY 2015 to FY 2016. Allocations by institution are shown in Appendix IIIB. Appendix IIIC lists the changes from FY 2015 to FY 2016 in the Special Funding Initiatives.

# FY 2016 Budget:

The state funds budget for FY 2016 is \$2.02 billion, including \$1.796 billion in formula funds and \$225 million in all other line items. The FY 2016 budget represents a total net increase of \$81.3 million, or 4.19%.

#### FY 2016 Additions: \$77.0 Million

The \$77.0 million increase for fiscal year 2016 includes the following major components:

- \$67.3 million for the formula funds:
  - o \$7.6 million for instruction due to increase in high-cost credit hours
  - o \$6.9 million for maintenance and operations of new facilities
  - o \$10.0 million for merit-based pay adjustments and employee recruitment and retention initiatives
  - o \$15.1 million for the TRS rate increase from 13.15% to 14.27%
  - o \$146,493 for Employees' Retirement System (ERS) rate increase
  - o \$16.8 million for the employer share of health insurance
  - o \$5.3 million for new system retiree health benefits
  - o \$1.3 million for debt service payback projects at four institutions

- o \$1 million for advanced manufacturing at Georgia Southern University
- o \$485,000 for the Military and Academic Training Center in Warner Robins
- o \$943,000 for a new University of North Georgia instructional campus site
- o \$1.7 million for adjustment to DOAS administered insurance programs
- o \$50,000 for statewide economic extension activities
- o \$39,000 for the Georgia Capital Agricultural History Museum
- \$9.7 million in increases for line items:
  - o \$2.56 million for the Georgia Film Academy
  - o \$1.2 million for the Advanced Technology Development Center
  - o \$1.3 million for merit-based pay adjustments and employee recruitment and retention initiatives
  - o \$1.8 million for employer share of health insurance and retiree health benefits
  - o \$878,202 for the TRS and ERS rate increases
  - o \$300,000 for Georgia Youth Science Technology Center
  - o \$520,000 to support the Agricultural Experiment Station
  - o \$360,000 to support the Cooperative Extension Service
  - o \$300,000 to support the Forestry Cooperative Extension
  - o \$169,569 for maintenance and operations at the Marine Institute
  - o \$158,154 in funding for the Public Libraries formula increase
  - o \$96,000 to support teacher and leader preparation
  - o \$27,200 for SREB payments

These increases reflect the State's continued commitment to the University System of Georgia to fulfill its mission of teaching, research and service.

### FY 2016 Net Reductions, Transfers and Other Adjustments: \$2.77 Million

- Reduce funding for Georgia Gwinnett College by \$1,375,000 to reflect year two of the plan to eliminate start-up funds over a seven year period
- Reduce funds for the film curriculum development by \$200,000
- Transfer \$1.0 million in funding for the Health Professions Initiative to the Georgia Board for Physician Workforce
- Transfer \$5.1 million state funds and \$247,158 tobacco funds for Georgia Research Alliance to the Board of Regents

# 4. <u>Fiscal Year 2016 Budget Allocations (Continued)</u>

# **FY 2016 Allocation Recommendations:**

Allocations of state funds by institution are listed in Appendix IIIB.

- The strategy employed in allocating the \$7.6M in new enrollment funding seeks to appropriate funding for growth while mitigating reductions on a case-by-case basis after carefully accessing the impact on each institution.
- Allocations of merit funding are allocated to institutions in proportion to salary requirements at each institution.
- Allocations of cost increases for maintenance and operations for new space are allocated based on institutional projections of cost increases.
- Allocations of cost increases for health insurance, new retiree health benefits, and the TRS and ERS rate increases are allocated based on institutional projections of cost increases.
- Any changes identified specifically by House Bill 76 were made accordingly.

## **FY 2016 Capital Budget:**

The total bond package for capital projects for the Board of Regents is approximately \$334.19 million for FY 2016 and includes:

- \$60 million for Major Repairs and Rehabilitation (MRR) for USG institutions
- \$3.3 million for equipment for buildings previously funded for design and construction at the University of Georgia
- \$162.005 million in construction funds for projects at the University of Georgia, Georgia Southern University, Albany State University, Columbus State University, Georgia College and State University, Savannah State University and Georgia Gwinnett College
- \$9.8 million in planning and design funds for the University of West Georgia, Armstrong State University, Clayton State University, the University of North Georgia, Atlanta Metropolitan State College and Georgia Perimeter College
- \$41.5 million for 11 small capital projects are various institutions
- \$5 million for the Animal and Dairy Science Building Restoration in Tifton at the University of Georgia
- \$1.5 million for the Construction Truck Driving Pad in Warner Robins at Middle Georgia State University
- \$4 million for Equipment for the Georgia Film Academy
- \$20.9 million for Facility Improvements for Roosevelt Warm Springs at Georgia Regents University
- \$1.5 million for Equipment at the Athens and Tifton Veterinary Diagnostic Laboratories

- \$10.81 million for the Georgia Research Alliance equipment
- \$11.95 million for the Georgia Public Libraries

# 5. Fiscal Year 2016 Salary and Wage Administration Policy

<u>Recommended</u>: That the Board approve the fiscal year 2016 salary and wage administration policy for the University System of Georgia.

<u>Background</u>: The FY 2016 budget includes \$11.3 million in state funds for merit-based pay adjustments and employee recruitment and retention initiatives.

<u>Policy</u>: The Board of Regents allocated to each institution funds to provide for salary increases for employees. Salary increases shall be awarded solely on merit, with a range determined by the institutional president. Institutions are permitted to augment state funds using other appropriate fund sources to create a salary pool. It is expected that individual merit salary increases will be reasonably distributed among employees based on the range determined by the institutional president. Across-the-board increases are not permitted. Salary increases may exceed ten percent for employees exhibiting exceptionally meritorious performance; however, institutions must request prior approval from the Chancellor in writing of any merit increases exceeding ten percent.

Additionally, the policy allows flexibility for institutions to make appropriate promotions or position reclassifications, special changes to recruit or retain employees, adjustments for targeted populations or adjustments to address market and compression issues. Such salary adjustments must be supported by appropriate documentation (e.g., market analysis or internal salary studies).

Employees covered from other fund sources such as sponsored funds and auxiliary funds will be subject to the same policy requirements noted above and must be paid from the corresponding fund source rather than state funds.

#### 1. Retirement Savings Plans Audit Update and Plan of Action

Beginning in February 2014, the University System of Georgia's Office of Internal Audit and Compliance, conducted an audit of the USG institutional retirement plans and other deferred compensation arrangements.

The scope of the audit included:

- A review of existing retirement plans,
- A review of atypical compensation plans, and
- Determination of compliance with applicable laws and regulations pertaining to the administration and management of these plans, to include BOR policy and procedures

The audit was performed with assistance from Strategic Benefit Advisors, Inc. (SBA), a consulting group specializing in benefit plan design and compliance.

The audit was completed in July 2014 and the USG institutions were given the opportunity to respond to the audit findings in September 2014.

Generally, the audit found issues that need to be addressed at every institution and nearly all institutions were found to have noncompliance issues specifically related to the administration and management of the plans. In addition, the audit found lack of education and training for the staff managing these plans.

Short and long term plans of action have been developed to address these issues.

### 1. <u>Establishment of a Bachelor of Business Administration with a major in Business</u> Administration, Atlanta Metropolitan State College

<u>Recommendation:</u> That the Board approve the request of President Gary McGaha that Atlanta Metropolitan State College ("AMSC") be authorized to establish a Bachelor of Business Administration (B.B.A.) with a major in Business Administration, effective April 15, 2015.

**Program Summary:** The proposed Bachelor of Business Administration (BBA) degree will allow AMSC students to complete a baccalaureate degree in Business Administration, rather than requiring students to transfer after completing an associate's degree.

BBA students will receive a solid foundation in the basics of business administration and management and will be allowed to tailor a program to meet their specific goals (e.g., starting their own business, joining corporate America, exploring international business opportunities, or working with nonprofit organizations). Through guided elective courses, the BBA program will also provide students the opportunity to pursue specific areas of interest by collaborating with AMSC's existing campus programs. Students who desire to pursue management positions in Digital and Entertainment industries will have the opportunity to take at least two courses from the Digital and Entertainment Design program currently being offered in the Division of Humanities and Fine Arts. Students interested in entrepreneurship careers will have the opportunity to take three courses in entrepreneurship. They will also have access to resources existing within the AMSC Center for Entrepreneurship. The Center for Entrepreneurship provides assistance in writing business plans and opportunities for professional internship placement and other applied experiences.

AMSC will be the only access institution within the University System of Georgia (USG) in the metropolitan Atlanta area offering a baccalaureate degree in Business Administration that prepares students to pursue employment or graduate work in business management. Program courses will draw from existing AMSC programs within the Division of Business and Computer Science and the Division of Humanities and Fine Arts. A three credit hour Internship/Co-op will be required of all students in the BBA program. The primary delivery method for the BBA degree program will be in the "face-to-face" format. Other formats and technological methods will be utilized, including hybrid and online courses to provide flexibility in scheduling. Currently AMSC's Association of Science in Business programs are nationally accredited by the Accreditation Council for Business Schools and Programs (ACBSP). The college will seek ACBSP accreditation for the BBA program once data has been collected.

<u>Fiscal Summary:</u> Resources for this program will come from new funds generated as a result of tuition revenue from enrollment growth and tuition rate increases. Additionally, a portion of the increase in the state allocation will also be earmarked as a source of funds for the BBA program. In the longer term, the program will be entirely supported by tuition revenues.

<u>Facilities Impact:</u> The program will be delivered using existing space and technology infrastructure at the institution.

**Accountability:** The Office of Academic Affairs will work with the institution to measure the success and continued effectiveness of the proposed program. The program will be reviewed in concert with the institution's programmatic schedule of comprehensive program reviews.

## 2. <u>Establishment of a Bachelor of Science with a major in Environmental Science, Georgia Gwinnett College</u>

**Recommendation:** That the Board approve the request of President Stanley C. Preczewski, that Georgia Gwinnett College ("GGC") be authorized to establish a Bachelor of Science (B.S.) with a major in Environmental Science, effective April 15, 2015.

**Program Summary:** The proposed B.S. degree with a major in Environmental Science will provide an interdisciplinary education for students interested in pressing environmental issues in the natural and social sciences. The Natural Science degree concentration will focus on physical, chemical, and biological factors associated with environmental quality and environmental policy-making decisions. The Social Science degree concentration will focus on the social and economic context in which environmental policy-making decisions are made. Both degree concentrations will direct students to take an active role in environmental decision-making at local, state, national, and international levels. The proposed program will offer practical and applied learning experiences that prepare students for post-graduate schooling or for positions of responsibility in education, industry, medicine, or government.

The proposed program will provide an undergraduate education for graduates entering one of the projected fastest growing job sectors in the United States, according to the US Bureau of Labor Statistics. In addition, GGC is uniquely positioned to enable more first-generation, ethnically diverse students to major in STEM fields. Currently, GGC's student body is 38.7% Caucasian, 31.4% African-American, 15.6% Hispanic, 9.4% Asian/Pacific Islander, and 4.9% other/not reported. Also, Georgia Gwinnett College already has a significantly large number of STEM majors. In fall 2014, 28%, of GGC's 10,800+ students were majoring in STEM fields. The program will be taught primarily through the use of face-to-face courses on the GGC campus. Some hybrid courses may be developed.

#### 3. <u>Establishment of a Master of Science with a major in Healthcare Management and</u> Informatics, Kennesaw State University

**Recommendation:** That the Board approve the request of President Daniel Papp that Kennesaw State University ("KSU") be authorized to establish a Master of Science with a major in Healthcare Management and Informatics, effective April 15, 2015.

**Program Summary:** The proposed graduate program is an interdisciplinary program spanning three colleges (Coles College of Business, College of Science and Mathematics, and Wellstar College of Health and Human Sciences) and four departments (Information Systems, Computer Science, Mathematics and Statistics, and Nursing). The program is designed to be a premier program addressing the need to produce a skilled workforce to meet the exponentially growing demand of Health IT sector.

The design and curricular components are based on the nationally accepted standards set up by the Commission on Accreditation for Health Informatics and Information Management Education (CAHIM). The proposed curriculum utilizes an interdisciplinary approach towards providing integrated knowledge spanning the domains of the practice and delivery of healthcare; information technology; computing; data analytics; informatics; and leadership/management principles. This collaborative approach will allow our graduates to understand the complexities and interdependencies among relationships that must be considered when making technology and management decisions within a healthcare organization and the key role that informatics can play in the delivery and practice of quality healthcare by provision of relevant information to the decision makers (clinicians, executives, technicians etc.) as and when required. The graduates of the proposed program will be able to utilize the solid foundation provided in the program to take diverse roles as leaders and healthcare executives; chief medical informatics officer (CMIO); chief information officer (CIO), project managers; VP of IT; developers; analysts; and informaticians in the healthcare industry.

The graduate program in Healthcare Management and Informatics will be housed in the Coles College of Business, Department of Information Systems. The program will follow a cohort model and will be delivered on campus over four semesters. There are 11 courses in the program, with a total of 36 credit hours offered during the course of the program. The program offers 33 hours of required coursework and 3 hours of elective.

#### **List of Similar Existing USG Programs and Productivity:**

No other similar programs exist within the USG. Two Master of Science in Analytics programs were approved during academic year 2014 at Georgia State University and Georgia Institute of Technology. The table below provides data for a broader variety of master's level programs inclusive of health services administration and healthcare administration.

<u>Fiscal Summary:</u> KSU has requested a premium tuition. With approval of the premium tuition, on this same BOR agenda, all program-related costs will be covered.

<u>Facilities Impact:</u> The program will be delivered using existing space and technology infrastructure at the institution.

**Accountability:** The Office of Academic Affairs will work with the institution to measure the success and continued effectiveness of the proposed program. The program will be reviewed in concert with the institution's programmatic schedule of comprehensive program reviews.

## 4. <u>Establishment of a Master of Science in Nursing with a major in Adult/Gerontology</u> Acute Care Nurse Practitioner, Middle Georgia State College

<u>Recommendation:</u> That the Board approve the request of President Christopher Blake that Middle Georgia State College ("MGSC") be authorized to establish a Master of Science in Nursing with a major in Adult/Gerontology Acute Care Nurse Practitioner, effective April 15, 2015.

**Program Summary:** As the first nursing master's degree this program builds upon the highly successful and respected pre-licensure nursing and RN-BSN programs offered at the college. The proposed program, which focuses on care for an adult and elderly population, responds to a critical need for the region, the state, and the nation. There is an urgent regional need for advanced practice Nurse Practitioners with the knowledge and skills to provide quality care to the adult and elderly populations.

Georgia is one of twelve states reporting greater than 1 million adults aged 65 and older. These 12 states combined, comprise 59% of the total population of older adults in the United States. Specialized nursing care for this specific population requires in-depth understanding of complex physical, social, and cognitive needs to maintain optimum health and functional independence, and to reduce the risk of complications associated with chronic illness and co-morbid conditions. Advanced practice nurses are well-suited to serve this population, yet few programs exist in Georgia to prepare Nurse Practitioners to meet the complex needs of the elderly population.

The MGSC nursing programs have strong community partnerships with various healthcare agencies across the region. The proposed MSN program will further expand other current School of Health Science's partnerships in the areas of long term care and acute care. Graduates will possess the skills to provide and manage advanced nursing care for the adult patient in acute healthcare environments including emergency rooms, intensive care units, trauma units, and in advanced diagnostic areas.

The proposed program will be housed on the Warner Robins campus of Middle Georgia College. There will also be online courses and clinicals arranged with regional health care facility partners. The program will be consistent with the Accrediting Commission for Education in Nursing (ACEN) standards of Master's level nursing education. The curriculum is in compliance with the American Association of Colleges of Nursing (AACN), the National Organization of Nurse Practitioner Faculties (NONPF), and the Georgia Board of Regents academic program policy. MGSC will seek ACEN accreditation for the program upon approval of the program by the BOR.

The program will require a degree credit hour waiver. The American Nurses Credentialing Center (ANCC) requires a minimum of 500 clinical practice hours in order for graduates to be eligible to sit for the Nurse Practitioner certification exam. In order to achieve the requirement of 500 clinical practice hours, the standard of equating one credit hour for three clinical contact hours was used. The program requirement of 43 credit hours is within the range of existing Master's level Nurse Practitioner programs within the region, state and nation. Therefore, there will be no significant impact on students.

<u>Fiscal Summary:</u> Resources for this program will come from new funds generated as a result of tuition revenue from enrollment growth and tuition rate increases. In the longer term, the program will be entirely supported by tuition revenues.

**Accountability:** The Office of Academic Affairs will work with the institution to measure the success and continued effectiveness of the proposed program. The program will be reviewed in concert with the institution's programmatic schedule of comprehensive program reviews.

5. Request for a Substantive Change to the existing Master of Education (M.Ed.) with a major in Health and Physical Education program to create a stand-alone M.A.T with a major in Health and Physical Education, Georgia State University

**Recommended:** That the Board approve the request of President Mark Becker that Georgia State University ("GSU") be authorized to substantively change the existing Master of Education (M.Ed.) with a major in Health and Physical Education to create a stand-alone Master of Arts in Teaching (M.A.T.) with a major in Health and Physical Education, effective April 15, 2015.

<u>Abstract:</u> Currently, GSU serves two different populations with the existing M.Ed. with a major in Health and Physical Education program: students who have initial certification and those who have a degree in another content area but are now seeking initial licensure. GSU seeks to create a stand-alone MAT degree that will focus on students seeking initial licensure, while retaining the M.Ed. to target certified teachers. GSU currently has 18 students enrolled in this M.Ed., and projects that enrollments will increase in both programs as the specific needs of each population are met.

## 6. Request for a Substantive Change to the existing Bachelor of Landscape Architecture (B.L.A.), University of Georgia

**Recommended:** That the Board approve the request of President Jere Morehead that the University of Georgia ("UGA") be authorized to substantively change the existing Bachelor of Landscape Architecture, effective April 15, 2015.

<u>Abstract:</u> UGA seeks approval to decrease the number of hours required for the major in Landscape Architecture (B.L.A.) from 150 to 120 hours. The request for this change is prompted by a decline in the enrollment in the major and the national trend to reduce the duration of the program from five years to four years. The proposed shortened program of study does not adversely affect the program's educational quality or content, or accreditation status with the Landscape Architecture Accreditation Board (LAAB).

From a content perspective, the proposed four-year degree program is restructured in such a way that only two courses within the existing five-year program are eliminated due to the redundancy of the material from these classes being covered in other courses. From a quality perspective, the proposed four-year degree program enhances the quality of the program through: (1) integration of digital technology into design studio courses in order to improve the efficiency and timing of content delivery and output; (2) adopting a new pedagogical teaching model for design studio courses that mirrors the workflow and operating procedures of professional design offices; and (3) adjusting curriculum content, sequencing, and adding flexibility to reflect changes in the national licensing exam (LARE) and developing specializations within the profession of landscape architecture.

## 7. Renaming of the existing Institute of Culinary Sustainability and Hospitality to the Michael A. Leven School of Culinary Sustainability and Hospitality, Kennesaw State University

**Recommended:** That the Board approve the request of President Daniel Papp that Kennesaw State University ("KSU") be authorized to rename the existing Institute of Culinary Sustainability and Hospitality to the Michael A. Leven School of Culinary Sustainability and Hospitality, effective April 15, 2015.

Abstract: The renaming of the Institute is in recognition of Mr. Michael Leven's \$5 million gift commitment to support KSU's highly successful Culinary Sustainability and Hospitality program. Mr. Leven recently retired as president of the Las Vegas Sands Hotel Corporation after a 44-year career in the hospitality industry, including terms as president of Holiday Inn Worldwide and President and COO of Days Inn of America. He currently serves as Chairman and Chief Executive Office of the Georgia Aquarium. Mr. Levin's substantial contribution will provide funds for an Endowed Chair, scholarships for students with financial need, and other programmatic enhancements.

#### 8. <u>a. Establishment of the Vasser Woolley Chair, Georgia Institute of Technology</u>

**Recommended:** That the Board approve the request of President G. P. Peterson that the Georgia Institute of Technology ("GIT") be authorized to establish the Vasser Woolley Chair, effective April 15, 2015.

<u>Abstract</u>: Georgia Institute of Technology seeks approval to establish the Vasser Woolley Chair to be housed in the School of Chemistry and Biochemistry of the College of Sciences. The Georgia Tech Foundation has confirmed that funds available to support the Chair total to at least \$1.5 million. The Chair is supported through the philanthropy of the Vasser Woolley Foundation, Inc. The first Vasser Woolley Chair was created in year 2007. Subsequent growth has enabled support for an additional chair. It is anticipated that the Vasser Woolley Chair shall enhance the School of Chemistry and Biochemistry in its efforts to recruit and retain teacher-scholars to positions of academic leadership.

Background: The beginning of the Vasser Woolley Foundation can be traced to the 1917 establishment of the Seydell-Woolley Company, a family business that specialized in the processing of chemicals, in particular sizing, for the textile industry. Several members of the family-owned business are Georgia Tech alumni. The company experienced growth during the 1960s and 1970s such that major product use occurred with organizations involved in textiles, construction, mining, adhesives, and coatings. The present day Seydel Companies, Inc. develops, manufactures, and markets textile process chemicals globally. The Vasser Woolley Foundation was incorporated in 1961 in Georgia and focuses on the arts and education. The Foundation was named in memory of Vasser Woolley Jr., who was born in 1896 and distinguished himself in the areas of textiles and real estate. Mr. Woolley later was found deceased in the 1962 Paris airplane crash along with 122 prominent Atlantans.

#### 8. <u>b. Establishment of the Sharon A. and David B. Pearce Professorship I,</u> Georgia Institute of Technology

**Recommended:** That the Board approve the request of President G. P. Peterson that the Georgia Institute of Technology ("GIT") be authorized to establish the Sharon A. and David B. Pearce Professorship I, effective April 15, 2015.

<u>Abstract:</u> Georgia Institute of Technology seeks approval to establish the Sharon A. and David B. Pearce Professorship I within the Scheller College of Business. The Georgia Tech Foundation has confirmed that funds available to support the Professorship total to at least \$750,000. The Professorship is supported through the philanthropy of Sharon A. and David B. Pearce. It is anticipated that the Professorship shall enhance the Scheller College of Business in its efforts to recruit and retain teacher-scholars to this position of academic leadership.

**Biosketch:** Mr. David Pearce currently serves as executive chairman of Vitriflex, Inc. a developer of gas barrier film solar technology. He also serves as a venture partner at Draper Nexus, assessing business plans for investment in the U.S.-Japan venture capital firm, and as chairman at Tusaar Corp., a technology startup. David Pearce retired in August 2012 as chief executive officer of NuvoSun, a thin-film solar manufacturing company which he founded in 2008. Prior to NuvoSun, Mr. Pearce founded MiaSolé, a thin film solar panel efficiency company where he served as chief executive officer for six years. He has founded and served as CEO or president of four venture-backed companies including MiaSolé, Optcom, an optical component company, SciVac, Inc. a vacuum system capital equipment company, and JTS Corporation, a disk drive company. Mr. Pearce came to Silicon Valley in 1985 as CEO of Domain Technology, a pioneer in thin-film media for the data storage industry, a company he took public in 1987. Mr. Pearce's career began in 1972 at Xerox Corporation in Plano, Texas.

#### 8. c. Establishment of the Neal Family Chair, Georgia Institute of Technology

**Recommended:** That the Board approve the request of President G. P. Peterson that the Georgia Institute of Technology ("GIT") be authorized to establish the Neal Family Chair, effective April 15, 2015.

<u>Abstract</u>: Georgia Institute of Technology seeks approval to establish the Neal Family Chair in the Sam Nunn School of International Affairs within the Ivan College of Liberal Arts. The Georgia Tech Foundation has confirmed that funds available to support the Chair total to at least \$1.5 million. The Chair is supported through the philanthropy of Michael Neal. It is anticipated that the Chair shall enhance the Sam Nunn School of International Affairs in its efforts to recruit and retain teacher-scholars to this position of academic leadership.

Biosketch: Mr. Michael Neal joined General Electric Company (NYSE: GE) in 1979. By 1987, he was named vice president and general manager of Vendor Financial Services. Three years later Mr. Neal became general manager of GE Commercial Equipment Financing (CEF). Under his leadership, CEF became the world's largest provider of financing for equipment of all types. He then served as GE Capital executive vice president from 1994 to 1999, a period of sharp growth for the financial services businesses. In 2000, he was named GE Capital's president and chief operating officer. In 2002, he became president and chief executive officer of GE Commercial Finance and president of GE Capital Services. Three years later, he was named a vice chairman of General Electric Company and chairman of GE Capital Corporation. After serving thirty-four years with the company, Mr. Neal retired as a vice chairman of General Electric Company and as chairman and chief executive officer of GE Capital Services in December 2013. Mr. Neal currently serves on the JPMorgan Chase & Co. Board of Directors. He also serves on the advisory boards of the Sam Nunn School of International Affairs at Georgia Tech, the Carey Business School at Johns Hopkins University where he is executive in residence and senior advisor to the Dean, the Georgia Tech Campaign Steering Committee, and the Georgia Tech Foundation Board of Trustees.

### 8. <u>d. Establishment of the William R. McLain Faculty Appointments, Georgia Institute</u> of Technology

**Recommended:** That the Board approve the request of President G. P. Peterson that the Georgia Institute of Technology ("GIT") be authorized to establish the William R. McLain faculty appointments, effective April 15, 2015.

Abstract: Georgia Institute of Technology seeks approval to establish the William R. McLain Faculty Appointments in the School of Chemical and Biomolecular Engineering in the College of Engineering. The Georgia Tech Foundation has confirmed that funds available to support the special faculty positions total to at least \$1 million (\$500,000 designated to each). The special faculty positions are supported through the philanthropy of William R. McLain. It is anticipated that the appointments shall enhance the School of Chemical and Biomolecular Engineering in its efforts to recruit and retain faculty members to positions of academic leadership in the field of polymers and related materials. The donor agreement indicates that the School will be afforded the flexibility in determining deployment of the fund distribution in support of faculty positions inclusive of professorships and chairs.

**Biosketch:** Mr. William R. McLain, a 1941 chemical engineering graduate of Georgia Tech, was the founder, chairman, and chief executive officer of Kusan, Inc. of Tennessee. Kusan, Inc. was a brand name for materials used in industrial components and toys. The company molded, decorated, and assembled plastic components for major industries. Mr. McLain's passion was in the area of plastics research. An article contributor to national trade journals, Mr. McLain was an inventor and held several toy patents. He was a former trustee and past chairman of the Georgia Tech Advisory Board.

### 8. <u>e. Establishment of the College of Veterinary Medicine/UGA Foundation</u> Distinguished Professorship in Infectious Diseases, University of Georgia

**Recommended:** That the Board approve the request of President Jere Morehead that the University of Georgia ("UGA") be authorized to establish the College of Veterinary Medicine/UGA Foundation Distinguished Professorship in Infectious Diseases, effective April 15, 2015.

Abstract: The University of Georgia seeks approval to establish the College of Veterinary Medicine/UGA Foundation Distinguished Professorship in Infectious Diseases to be housed within the College of Veterinary Medicine. The College of Veterinary Medicine established the endowed fund with an initial investment of \$500,000. The University of Georgia Foundation reports that funds on deposit have a current balance of \$499,937.90 for the special faculty position as of March 31, 2015. The holder of the endowed position will have an outstanding record in externally funded research and publications as well as bring currently funded research to the University. The holder of the position is expected to engage in teaching, research, and public service. The endowed position will not be held in conjunction with any other chair or special professorship. The purpose of the endowed position is to support scholarly activities. The Distinguished Professorship will be housed in the Department of Infectious Diseases.

#### 1. Guaranteed Energy Savings Performance Contracts Update

Vice Chancellor Jim James and Director of Management and Operations, Ken Crowe, will update the Board on the implementation of the Fiscal Year 2015 Guaranteed Energy Savings Performance Contract program.

In January 2014, the Board was informed about this program, which allows capital renewal projects that improve energy efficiency to be funded using energy and operational savings over a multi-year period. The Board subsequently approved the appointment of an energy services provider for a project at Georgia Institute of Technology in October 2014 and at the University of Georgia in November 2014.

The selected energy services provider has completed an Investment Grade Energy Audit and identified the proposed Energy Conservation Measures (ECM) for each institution listed below.

This is provided as information only. It is anticipated that Board authorization of both projects will be requested in May, after contract conditions and financial closing documents are fully developed.

#### 2. <u>High Performance Computing Center, Georgia Institute of Technology</u>

Vice Chancellor Jim James will present an update on a proposed project by Georgia Institute of Technology ("GIT") to partner with a developer on the design and construction of the High Performance Computing Center in Technology Square. The Board was previously informed about this project in January 2015 through a presentation by President G.P. "Bud" Peterson. Since that time, GIT has initiated the process to select a developer for the project. Two developers have been selected as finalists through a rigorous, qualifications-based shortlisting process and from an initial pool of eight firms. Selection of the final developer is expected in late April 2015.

GIT proposes to lease approximately 340,000 square feet ("SF") of space as anchor tenant in the new development, including a 40,000 SF data center and 300,000 SF in computational lab, research, teaching and office space. The development would be located on a block of property owned by the Georgia Tech Foundation ("Foundation") and bounded by Spring Street NW, Armstead Place NW, West Peachtree Street NW and 4<sup>th</sup> Street NW. The Foundation intends to ground lease the site to the developer.

The lease is anticipated to start in early 2018, with a ten-year initial term followed by five annual renewal options. Lease and operating costs will be paid from a combination of institutional funds, donations, and indirect cost recovery funds from the Georgia Tech Research Institute.

Future Board action will be required to approve the final scope and lease terms for this proposed project and to authorize execution of the lease.

#### 3. Van Leer Interdisciplinary Design Commons, Georgia Institute of Technology

Georgia Institute of Technology ("GIT") proposes to renovate approximately 16,000 square feet within the existing Blake R. Van Leer Building to create the new Interdisciplinary Design Commons ("IDC") and construct an adjoining outdoor plaza.

The Van Leer Building, located in the center of the campus at the corner of Tech Green and Atlantic Drive, was constructed in 1962 and provides offices, classrooms and laboratory space for the School of Electrical and Computer Engineering. The proposed project would transform the building's two-story rotunda into a student design facility that contains state-of-the-art computing and simulation tools and studio spaces, which is intended to encourage collaboration and innovation among students from all disciplines.

The scope of work would include a comprehensive renovation of existing student study and instructional space to create laboratories, shop spaces, and meeting spaces to support student design and fabrication activities, as well as assembly, prototyping, and testing. Removal of lead paint and asbestos and replacement of mechanical systems is included in the project scope. An outdoor plaza accessible from the ground floor of the rotunda will be constructed in association with the renovation, to provide space for display of student projects and add visibility to the IDC from the surrounding campus area.

The total project cost is estimated at \$11 million, with \$4.6 million from institution funds and \$6.4 million from private donations. The IDC is expected to be operational in August 2017.

Future Board action will be required to authorize the project.

# 4. Appointment of Design Professional Firm, Project No. BR-50-1501, Science Park Phase II Build-out, Georgia State University

<u>Recommended</u>: That the Board approve the ranking of the named design professional firms listed below for the identified project and authorize contract negotiations to proceed with the topranked firm, and authorize the execution of a contract with the top-ranked firm. Should it not be possible to execute a contract with the top-ranked firm, staff will then attempt to negotiate and execute a contract with the other listed firms in rank order.

Following public advertisement, a qualifications-based selection process was held in accordance with Board of Regents procedures. The following recommendation is made:

Project No. BR-50-1501, Science Park Phase II Build-out, Georgia State University

Project Description: This project was authorized by the Board in March 2015. Two floors of the build-out will be open research laboratories with support spaces and the third will be a small vivarium. Mechanical, electrical and fire protection work for these floors will be included in the project. The build-out will also include the installation of a backup chiller and cooling tower for the HVAC system, a secondary passenger elevator and a fully enclosed, elevated pedestrian bridge connecting the Phase II building to the Petit Science Center.

The project will be funded from institutional indirect cost recovery funds.

Total Project Cost: \$19,489,000 Construction Cost (Stated Cost Limitation): \$15,000,000

# 5. <u>Appointment of Design Build Firm, Project No. BR-66-1501, Central Warehouse, Georgia Southern University</u>

#### 6. Naming of the Garden Club Terrace at Foley Field Stadium, University of Georgia

<u>Recommended</u>: That the Board approve the naming of the right field terrace at Foley Field Stadium, University of Georgia ("UGA") the "Garden Club Terrace" in honor of Bill Powell, Dick Copas, and Reid Parker.

<u>Understandings</u>: President W. Jere Morehead confirms that this naming conforms to the UGA naming guidelines and with the Board of Regents naming policy.

Dr. Bill Powell, who retired in 1993, was a Professor of Plant Pathology in the UGA College of Agricultural and Environmental Sciences and UGA Athletic Association Faculty Athletic Representative.

Dick Copas was a UGA Golf Coach from 1971 to 1996 and UGA Athletic Association Academic Coordinator and Dormitory Supervisor.

Dr. Reid Parker, now deceased, was a faculty member and department head in the UGA School of Forestry and Natural Resources, UGA Athletic Association Academic Faculty Athletic Representative and Athletic Director for Administration.

#### 7. <u>Acquisition of Real Property, Street Abandonment – State Street and Atlantic</u> Drive, Georgia Institute of Technology

<u>Recommended</u>: That the Board authorize the purchase of approximately 0.91 acres of improved real property located on Atlantic Drive and State Street, Atlanta, from the City of Atlanta (the "City") for the use and benefit of the Georgia Institute of Technology ("GIT").

<u>Recommended further</u>: That the legal details involved with acquiring this real property be handled by the Georgia Department of Law.

<u>Understandings</u>: The portions of Atlantic Drive and State Street (the "Roads") located south of Peachtree Place were previously abandoned by the City of Atlanta. The remainder of the Roads between Peachtree Place and 10<sup>th</sup> Street (the "Rights-of-Way") have remained public as they were utilized to access private properties. With the exception of two parcels owned by The University Financing Foundation on the southwest corner of 10<sup>th</sup> Street and State Street, the Board of Regents has since acquired the properties that abut the Rights-of-Way.

The City's abandonment of the Rights-of-Way allows GIT to convert Atlantic Drive into a pedestrian promenade and widen State Street to accommodate new bike lanes and additional traffic from the North Campus Parking Deck. These acquisitions are necessary to support the newly constructed Engineered Biosystems Building and infrastructure associated with future buildings and the eco-commons project.


Appraisals procured by the City of Atlanta value the State Street abandonment at \$145,000 and the Atlantic Drive abandonment at \$125,000. Subject to the passage of abandonment legislation by the Atlanta City Council, the City will convey the Rights-of-Way to the Board of Regents for \$31,900 and other previous considerations associated with infrastructure improvements installed around the GIT campus.

An environmental site assessment of the Rights-of-Way has been conducted and indicates no significant adverse environmental issues.

There are no restrictions associated with the acquisition and no known reversions, restrictions or adverse easements associated with the real property to be acquired. The City will reserve any existing easements associated with the Rights-of-Way.

<u>Recommended</u>: That the Board declare its interest in approximately 7.344 acres of improved real property located at 1826 Veterans Boulevard, Dublin, Georgia, to be no longer advantageously useful to the Middle Georgia State College ("MGSC") or other units of the University System of Georgia ("USG") but only to the extent and for the purpose of allowing the reversion of this real property to the U.S. Department of Veterans Affairs ("VA") for the benefit of MGSC and the USG.

<u>Recommended further</u>: That the Board authorize the conveyance of the above property to the VA for title clearing purposes and other valuable consideration.

<u>Understandings</u>: In 2001, the VA donated approximately 39 acres of improved real property to the Board of Regents subject to the property reverting back if the property ceases to be used for educational purposes.

Approximately 7.344 of the donated 39 acres were improved with two buildings constructed in 1944 that are currently in need of extensive repair. MGSC does not use the buildings, and has no future plans to use or renovate the buildings. Upon reversion of the 7.334 acres, the VA intends to demolish the buildings and construct a surface parking plot to support the adjacent Carl Vinson VA Medical Center.

#### 9. Ground Lease, Skidaway Island Wind Turbine Project, University of Georgia

Recommended: That the Board declare approximately 6.08 acres of unimproved real property located along 10 Ocean Science Circle, Savannah, Georgia at the University of Georgia ("UGA"), Skidaway Institute of Oceanography to be no longer advantageously useful to UGA or other units of the University System of Georgia but only to the extent and for the purpose of ground leasing the property to Georgia Power Company ("GPC") to construct, operate and maintain as a research wind energy generation facility ("Small Wind Demonstration Project").

<u>Recommended further</u>: That the Board authorize the execution of a ground lease of the property to GPC for up to two years at a rent of \$5,168 (\$850 per acre) per year, together with an option to extend the ground lease for two additional six month periods.


<u>Recommended further</u>: That the Board authorize the execution of any necessary access, use, and construction easements, between the Board of Regents and GPC, for the above-referenced property for a period commensurate with that of the above-referenced ground lease for the purpose of constructing, operating and maintaining the Small Wind Demonstration Project.

<u>Understandings</u>: In February 2015, the Board was informed about the Small Wind Demonstration Project and that further action to lease the property was anticipated.

GPC intends to install a meteorological tower, four wind turbines and an underground electrical distribution system on the ground leased property to study the feasibility of small wind technologies and evaluate wind resources in the coastal area. Through this research partnership with GPC, Georgia Southern University will study the external and environmental impact of the turbines. In addition, GPC will transfer to UGA all renewable energy credits associated with this project. These credits will allow UGA to achieve a portion of the renewable energy goals in the UGA's 2020 Strategic Plan.

A Georgia Environmental Policy Act assessment has been completed and indicates no significant adverse environmental effects from this lease.

At the end of the lease term, the real property will revert to the Board of Regents and GPC will decommission the wind energy project and, at the option of UGA, convey the meteorological tower to the Board of Regents.



# 10. Naming of the Texas Instruments Plaza, Van Leer Building, Georgia Institute of Technology

<u>Recommended</u>: That the Board approve the naming of the exterior area adjacent to the Blake R. Van Leer Building Electrical and Computer Engineering Building ("Van Leer Building") at Georgia Institute of Technology ("GIT") the "Texas Instruments Plaza" in recognition of a gift from Texas Instruments Incorporated ("TI").

<u>Recommended further</u>: That the Board approve a waiver of Board Policy 7.4.1 at the request of President G.P. "Bud" Peterson to allow for the execution of the Gift/Pledge Fund Agreement and recognition of the naming prior to having half of the gift in hand.

<u>Recommended further</u>: That the above waiver of policy and approval of the named space be conditioned upon the Board's authorization of the associated construction project and GIT's receipt of the first installment of \$600,000 in cash from TI in March 2016.

<u>Recommended further</u>: That the above waiver of policy and approval of the named space will be vacated if TI does not execute the Gift/Pledge Fund Agreement within thirty days of the Board's action.

<u>Understandings</u>: Texas Instruments and GIT have had a strong forty year relationship, during which TI has provided over \$14.4 million in gifts and funded over \$10.5 million in sponsored research initiatives. The most recent gift totals \$3.2 million, including \$1 million to support the construction and naming of Texas Instruments Plaza.

\$3 million of the gift will be paid in cash in five annual installments of \$600,000 beginning in March 2016. The remaining \$200,000 is in in-kind contributions of technology.

The Van Leer Building, located at 777 Atlantic Drive on the main GIT campus, contains classrooms, instructional and research laboratories, and administrative and faculty offices in support of students, staff, and faculty in the School of Electrical and Computer Engineering.

#### 1. Information Item: Ethics and Compliance Hotline Update

The University System of Georgia implemented an ethics and compliance hotline in 2008 as part of our ethics and compliance program. All institutions of the University System plus the University System Office have a hotline system which allows users to anonymously report activities which may affect the operation of USG institutions. Input is either on-line or via telephone.

During this session, Chief Audit Officer and Associate Vice Chancellor John Fuchko, III will provide an overview of the cases received via the hotline and also discuss processes which are followed when cases received via the hotline or other methods that involve potential malfeasance.

#### **April 15, 2015**

1. <u>Information Item:</u> Update on GME expansion activities

The legislature appropriated a total of 5.275 million into the USG budget for FY 2015 to further ongoing efforts to create new residency programs at new teaching hospitals in Georgia. With the support provided by this funding, USG Efforts in FY 2015 will focus on further development of GME programs across the state. Dr. Shelley Nuss and Mr. Ben Robinson will provide the committee with a more detailed update on recent developments as well as a report on ongoing progress with existing and potential hospital partners.

### 2. **Action Item:** Approval of Recommendations from the GREAT

Background: Tanner Healthcare System, Athens Regional Healthcare system and Redmond Regional have undertaken ambitious efforts to expand GME across the state. Athens Regional has received approval from ACGME for its internal medicine Program. This program will receive its first residents by July 2016. The hospital is actively engaged in efforts to establish more programs by July 2017. Redmond Regional is on track to bring residents in its internal medicine on board by July 2016. Tanner Healthcare has submitted initial paperwork to receive institutional accreditation and anticipates a response from the ACGME by this May. The collective impact of these new programs would bring a total of 184 residents in five different specialties.

To facilitate the ongoing efforts with these hospitals the GREAT recommends \$2.4 million in additional funding for these programs.
