MINUTES OF THE MEETING OF THE BOARD OF REGENTS OF THE UNIVERSITY SYSTEM OF GEORGIA Atlanta, Georgia

September 14, 2016

CALL TO ORDER

The Board of Regents of the University System of Georgia met on Wednesday, Sept. 14, 2016, in via telephone and in Room 8026, 270 Washington Street SW, Atlanta, Georgia. The Chair of the Board, Regent Kessel D. Stelling, Jr., called the meeting to order at approximately 10:00 a.m. Present, in addition to Chair Stelling, were Vice C. Thomas Hopkins, Jr.,; and Regents C. Dean Alford; Larry R. Ellis; Rutledge A. Griffin, Jr.; James M. Hull; Donald M. Leebern, Jr.; Doreen Stiles Poitevint; Neil L. Pruitt, Jr.; E. Scott Smith; Benjamin J. Tarbutton, III; Richard L. Tucker; T. Rogers Wade; Larry Walker; Don L. Waters; and Philip A. Wilheit, Sr. Regents W. Paul Bowers and Sachin Shailendra were excused.

COMMITTEE ON FINANCE & BUSINESS OPERATIONS

Regent Neil L. Pruitt, Jr., convened the Committee on Finance & Business Operations. With motion made and variously seconded, the Regents who were present approved the following items:

- 1. The Board approved the fiscal year 2018 Operating and Capital Budget Requests, attached hereto as Appendices I and II.
- 2. The Board approved the Kennesaw State University Interim President Houston Davis's request to lower mandatory commuter meal plans from Access 40 to Access 25 for freshmen, and Access 14 to Access 7 for sophomores and juniors, reducing the cost from \$475 per semester to \$324 per semester for freshmen, and \$160 per semester to \$84 per semester for sophomores and juniors. These changes are to become effective Spring 2017.

REGENTS' NOMINATING COMMITTEE

With motion made and variously seconded, the Regents present voted to appoint Regent Neil L. Pruitt, Jr., Sachin Shailendra and Richard L. Tucker to serve on the Regents' Nominating Committee, with Regent Pruitt to chair. The committee will report back to the Board in October to propose a slate of officers for 2018.

EXECUTIVE SESSION

At approximately 10:25 a.m., Chair Stelling called for an executive session for the purpose of discussing personnel and compensation matters. With motion properly made and unanimously seconded, the Regents voted unanimously to go into executive session. University System of Georgia staff members who were also present for portions of the executive session included Chancellor Huckaby and members of his staff. An affidavit regarding this executive session is on file with the Office of the Secretary to the Board. Chair Stelling reconvened the Board meeting in its regular session at approximately 10:34 a.m., and announced that no actions were taken during the executive session.

There being no further business to come before the Board, the meeting was adjourned at approximately 10:35 a.m. Wednesday, Sept. 14, 2016.
