






## **Data Flow**






## **Data Validations Timeline**

## IPEDS HR Reports: Cognos Requires Review Errors





CHECK IPEDS HR REPORTS FOR REQUIRES REVIEW COLUMN REVIEW THE '<u>REQUIRES</u> <u>REVIEW USER GUIDE</u>' ONLINE

Employees in the 'Requires Review' column **do not** fit the definition of any IPEDS occupational category and **will not appear** in the IPEDS HR Survey upload file unless the job code or activity percent distributions are changed.



- No changes from NCES on the IPEDS survey
- Extraction & Report changes
  - Classification of Instructional Program (CIP)
  - Multiple Components of Pay (MCOP)
  - 9/10-month contract
  - Funding and Effort
  - Citizenship
  - Gender

## CIP

- NCES CIP codes were updated in 2020. Teaching CIPs will need to be updated in PeopleSoft.
- Will not impact IPEDS/Digest.

## MCOP

- Administrative supplement MCAFA will be added to base pay for administrative faculty.
- Will impact IPEDS/Digest reported salary.



### 9/10 Month Contract

- Previously, instructional staff that are not on 12-month contracts have been reported to IPEDS with contract length of 10 months. This is being changed to 9 months.
- This change stems from institutional feedback and allows for a more accurate calculation of '9 Month Equated' Salary Outlays by IPEDS.
- Annual salary calculated as usual. No impact on Digest HR Reports.

- If an institution believes that 10 months is a better representation of contract length they will need to:
  - Confirm rationale with their HR department
  - Send an email to HelpDesk requesting the change
  - RPA will work with you to create new upload file
  - NOTE: COGNOS REPORTS WILL <u>NOT CHANGE</u>. COGNOS WILL SHOW EMPLOYEES IN THE 9 MONTH CATEGORY EVEN IF A 10 MONTH EXCEPTION IS GRANTED.



### **Funding and Effort**

- Pull from top of stack with an effective date <u>earlier than or equal to</u> November 1, 2020.
- Will impact designation of Instructional Staff for IPEDS. No impact on Digest.

### Citizenship

- Pull from top of stack with an effective date <u>earlier than or equal to</u> November 1, 2020.
- Will impact designation of Race for IPEDS. No impact on Digest.

### Gender

- If Gender is not specified:
  - Will show as '<u>unknown</u>' on Cognos IPEDS HR.
  - As done in past years, will be reported as <u>female</u> in IPEDS
  - Will report as <u>female</u> in Digest Reports \*new\*
