


#### **Sector Dispersion of Terminated Programs**

Percent Terminated of Total Programs (n = 39)




# Update: Academic Programs Report Low-Producing Programs

Associate programs	Less than 5 graduates
Bachelor's programs	Less than 10 graduates
Master's programs	Less than 5 graduates
Specialist in Education programs	Less than 5 graduates
First Professional programs (M.D., D.D.S., J.D., D.V.M., Pharm.D.)	Less than 3 graduates
Doctoral programs (Ph.D., Ed.D., D.S.W., Dr.P.H., etc.)	Less than 3 graduates
