# COVID 19 Update

- Federal CARES Act provides regulatory relief, waivers, and funding
- Funding:
  - Governor's Education Relief Fund (\$104.5M for GA)
  - Higher Education Emergency Relief Fund (\$250M for USG)
    - 90% to institutions based on FTE of Pell and non-Pell students
      - At least 50% for student emergency aid
      - Up to 50% for institutional response to COVID 19
    - 7.5% to minority serving institutions
    - 2.5% to institutions deemed with highest need



# USG COVID-19 Responses

- Admissions changes due to lack of standardized testing(see details in notes)
  - SAT/ACT optional, GPA sector thresholds set in lieu of Freshman Index
  - Learning Support- without SAT/ACT/Accuplacer available, GPA thresholds set lower
  - English proficiency-DuoLingo added as test
  - Dual Enrollment-don't have to have scores



## USG COVID-19 Responses

- Tuition and Fees
  - Summer:
    - Undergrad online tuition differential eliminated (grad can remain)
    - Only mandatory fees allowed are Special Institutional Fee and Technology Fees

- Fall: no tuition increases for 2020-21 AY



## USG COVID-19 Responses

- Summer Online Instruction Coding
  - Institutions need to continue to make online delivery transparent to students
  - Can choose whether to update 3 ADC elements that signal course is online (
    - If don't, must map 2 and USG will update the 3<sup>rd</sup> post submission
  - Work with your fiscal affairs to ensure tuition and fees assessment follows USG guidance



# State Government

- Legislative Session
  - Amended FY20 budget approved (4% cuts but enrollment formula funds exempted)
  - FY2021 not approved yet
  - Session suspended at day 29/40
  - Dual Enrollment bill passed, awaits signature
    Bills on hazing and free speech crossed over



# USG Strategic Plan 2024

- Approved Nov. Board meeting
- Went into effect January
- Work to identify sector targets on metrics delayed due to COVID response
  - You may be called upon to assist your President with this work.

- **OneUSG Connect**-everyone in!
- Banner Managed Services-19 institutions on
- Know More Borrow Less -all institutions generating financial aid offer letters through Campus Logic this spring
- General Education Redesign -presented to Board as info item in February. Implementation pushed back some due to needed focus on COVID response.



# ADC Upcoming Changes

### Summer 2020 Midterm

- Change to method of collecting curriculum to improve user visibility and accuracy
  - New elements: Curriculum Priority Indicator and Curriculum Priority Indicator Enrolled
- New Test Score: DuoLingo
- 2020 CIP Changes –changes to lookup tables and turnaround reports to reflect updated codes



# ADC Upcoming Changes

### Fall 2020 End-of-Term

- High Impact Practice course section attribute changes
  - Separating out flag from duration codes
  - Adding an indicator if the course meets an institutional requirement



## 2020 CIP Update Process

- NCES Released 2020 CIP Codes
  - Institutions must use new CIP codes in IPEDS Reporting beginning Fall 2020
- Phase I
  - USG provided registrars instructions and spreadsheets about affected academic programs and courses
  - Institutions required to complete and return spreadsheets with decisions on changes
  - Academic Affairs reviews submissions and sends approval
  - Academic Services and RPA conducted webinar on updating 2020 CIP in Banner



## 2020 CIP Update Process

- Phase II
  - Institutions will update academic programs and course CIPs in Banner
  - USG will update DMA and data collection infrastructure
  - Note: Phase II will happen after ADC Spring EOT submission and before start of ADC Summer EOT collection
- Phase III
  - Work on updating CIP information in Facilities and HR systems

# National Student Clearinghouse

- Executed system-level Master Service Agreement (MSA) and Statements of Work for Student Tracker (basic) and Postsecondary Data Partnership(PDP).
- NSC has contacted each campus to execute its own MSA and Statements of Work for desired products
  - Use agreements negotiated by USG to be Georgia law compliant
- RPA is rerunning all PDP data and dashboards will be updated for campus use.



### NSSE/CCSSE

- NSSE was not making any accommodations due to survey already being in the field so we continued
- CCSSE allowed cancellation so all of those institutions will administer in 2021
