Pre-Service Certification part of the reason the pre-service certificate was started was to protect us from out of state providers

TCSG Education Degrees vs. MOUs - Some Technical colleges want to start education degrees. BOR must approve any Associate Degrees offered by TCSGs. Articulation agreements are the current path, if we are approached regarding degree, send them to the Provost and notify USG.

Online Degree Programs and e-Tuition (and special tuition requests) - audit of cost of education, there is a move (or seems to be) to make all tuition the same. ***Will need to justify use of e-Tuition for online programs.

Area F, CTAE, and Teacher Recruitment Pipeline - Foundation faculty working with high schools to better align he high school pathway with Area F courses.

Proposal Development and one-step proposal - budget and enrollment - Discussion at USG on how to make the process easier, budget is scrutinized (let Bob know if we need help), partnerships with community or businesses are favored. How are you packaging programs to meet minimum numbers. Continue to watch enrollments as they are still being reviewed carefully.

Wallace FOundation UPPI - Albany State University - University Principal Preparation Initiative - partnerhships with school districts, New York Leadership Academy, 5 year grant. Governor has leadership task force (schools, USG, DoE, PAGE) Principal Leadership Academy. Specifically to address principals in struggling schools. GELFA working on standards. ***Watch e-mail for more information

Woodrow Wilson Fellows Program - Any state money for continuing funding? UTeach

Computer Science, Online Teaching, and CBE - A lot of interest at the state level for these programs.

Competency based education in Henry County School System; Georgia Southwestern has CBE system that awards badges include meta data of competencies the students achieve and the assessments that shows they met those competencies. Exploring use of prior learning assessment - use as a recruiting tool, currently with CFO for development of pricing structure. Intent is to transfer as K credits. Focus primarily at the graduate level (Teacher Leadership endorsement is embedded in their Tler I Ed Leadership program). Valdosta is doing Math and Science Endorsements.

PPEM and Teacher Preparation Report - Data Dashboard being created. This is the year this becomes consequential. Will GaTAPP be scored as well? How are index scores computed?

EdTPA Results - Use Data Analyzer with our data.

Tristen Denley - Vice Chancellor - (from Tennessee BOR, formerly at Austin Peay) - exploring the questions data answers, data informed, not data driven, balance between commonality and individual flavor. At large scale finding techniques with which to enable more students to be successful.

Large scale initiative - ways to help previously struggling students be more successful without decreasing the rigor. Enable students to make purposeful choices when they come to college. Construction of choice architectures, especially when students do not have the appropriate information structures. Creating a clear pathway from where they are to move along that pathway, more than just classes they must take, experiential learning opportunities, in and our of class. Effective developmental education, use best practices that we now have (co-requisite approach - 2-3 times greater effectiveness than anything done in the past). Student recognize how he/she feels about him/herself as a learner - mindset. IRB willing, BOR will be administering an academic mindset assessment to all incoming freshmen this year. (Walton - CalTech). Education not a menu, it's a recipe.

Vision 2025 - College 2025 initiative Chancellor has asked him to head up, Group is tasked with looking at what college will look like in 2025. Structured, iterated interview. Is there a way in which we can represent the learning that has taken place in a degree program beyond the traditional transcript, which does not convey what was learned in a way that outsiders can understand.

How will we avidly and flexibly respond to the needs of our students, the workforce, etc? If USG can create the infrastructure that allows us to have that flexibility.

Will be changing the ways in which we can count degrees together. Tristen will be developing a mechanism for counting degrees together (e.g. A family of degrees, but call the degree what it is...B.A. In German as part of the family of degrees under Modern Languages). Will be friendly of

new degrees that fit into the broader lens of something else.

***Elevator speech - why should someone study your program?

Is there a need for creating something like a Regents Teaching Scholar? Could this help differentiate an exemplary graduate?
