1:15 Approval of <u>Old Minutes</u>--Dr. Bryan Davis

Dr. Davis made a motion to approve Fall 2020 minutes and was passed unanimously.

1:20 eCore Updates

- Enrollment and General Update--Dr. Melanie Clay
 - o Dr. Clay reported that there has been a steady increase in enrollment.
- Authentic Assessments and Proctored Exams--Dr. Melanie Clay
 - Dr. Clay reiterated the importance of proctored exams for identity verification and academic integrity. As a part of pandemic response, proctored exams were temporarily suspended. Proctored exams have resumed for math and science courses, and will be brought in other courses for Fall 21 semester. As a part of pandemic response, eCore courses prototyped authentic assessments last Spring, and for Fall in lieu of proctored events. eCampus is exploring authentic assessments as an alternative to requiring students to go to a testing site for a proctored experience. Examples of alternative assessments might include having students produce and submit video artifacts on major projects of significance.
 - o Partner Institutions provided suggestions on data review; adapting proctoring definitions and guidelines to present conditions for remote delivery;

considerations for student-centered experiences; engagement with faculty on disciplinary/pedagogical decisions; using Subject Matter Experts (SMEs) who work on course development and revision; academic integrity/visual identity verification and Title IV funding considerations.

- A motion was made regarding changing the language on proctoring requirements to leave it more open-ended. The motion was tabled until the Fall Meeting.
- Salesforce Adoption and Timeline--Jessica Blakemore
 - Progress report was given on updating the SEADS CRM application with a vendor-supported application, Salesforce Service Cloud.
- DATA 1501 Development Update--Jon Sizemore
 - o Report on System-wide effort to add DATA 1501 as a GenEd course. A RAC has been formed for Data Science . Institutions wishing to add the course to their general education curriculum can work with the GenEd Council to adopt the common course template.
- Professional Development Update--Dr. Amy Austin
 - o Facilitating Adult Online Learning Course designed for USG faculty who will be teaching adult learners in online classes and integrating adult learning principles into teaching methods. Other upcoming course topics include engaging students to thrive online, and using LMS to support classroom instruction.
